## **5.0 Discussion Items/Presentation Items**

### *5.1 CA High Speed Rail Project*

Jose Martinez (CHSRA) provided a project update on the Los Angeles/San Diego section of the CA High Speed Rail Project. Mr. Martinez indicated that the project provides numerous economic benefits to LA County through new jobs, tax revenues, and economic growth. In 2009, the CA High Speed Rail Authority conducted public scoping alternatives that resulted in numerous comments including the support of the addition of the I-10 as a possible route through the San Gabriel Valley. Mr. Martinez stated that the authority's next steps include finalizing the scoping report and conducting additional outreach to key stakeholders.

### *5.2 I-210 Corridor System Management Plan*

Tom Choe (Systems Metrics Group) gave a presentation on the benefits of a Corridor System Management Plan (CSMP) for the I-210 corridor stretching from Pasadena to San Dimas. Mr. Choe stated that congestion in the corridor has led to lost productivity due to reduced flow rates under 35 mph. In addition, the average hours of delay have been growing during the past 2 years along with specific travel times and collisions throughout the corridor. Mr. Choe also provided examples of bottlenecks throughout the 210 and their impact on congestion. The next steps for a CSMP include having cities provide a project list of potential projects to develop scenarios in the CSMP traffic model along with additional cost benefit analyses.

- 6.2.2 The subcommittee is trying to get word on the type of projects that cities can apply for regarding signal synchronization. MTA will be invited to conduct a workshop.

### 6.3 LA DWP San Gabriel Valley Traffic Forum

- 6.3.1 The San Gabriel Valley Traffic Forum distributed a status report on the Intelligent Transportation System (ITS) Project. Current projects include traffic signal control systems, communication system, and closed circuit television cameras along the primary arterial highways in the SGV.
