UPDATE ITEM

7. San Gabriel Valley Transit Feasibility Study

SGVCOG staff provided a presentation on this item. The Los Angeles County Metropolitan Transportation Authority (Metro) recently directed Metro staff to prepare an independent feasibility study that evaluates options to serve the mobility needs of the San Gabriel Valley. The San Gabriel Valley Transit Feasibility Study is anticipated to commence in FY 2021 with the goal of identifying short-term and long-term solutions that serve the mobility needs of the San Gabriel Valley region. The anticipated duration of the Study is approximately 18 months.

Questions/Discussions:

- A committee member inquired about Metro's outreach activities to the SGVCOG and SR-60 corridor cities regarding the development of the San Gabriel Valley Transit Feasibility Study. SGVCOG staff responded that the SGVCOG has been speaking with the Metro staff internally regarding the drafting of an MOU for this Study. Additionally, the SGVCOG will be providing relevant updates to the SR-60 corridor cities in the near future regarding the development of this Study.

PRESENTATIONS

8. Metro BRT Vision and Principles Study

Metro Project Manager, Lauren Cencic, provided a presentation on this item. The Metro Bus Rapid Transit (BRT) Vision and Principles Study seeks to establish and build consensus on a clear vision for the BRT system and develop guidance on the design of the BRT network. The Study will also facilitate the identification and

prioritization of future BRT candidate corridors, including the first phase of the Measure M BRT project, which has an expected opening date between FY 2022 to FY 2024.

Questions/Discussions:

- A committee member inquired about potential corridors that other San Gabriel Valley transit service providers are considering implementing BRT routes. Metro staff responded that Valley Boulevard, Ramona, and SR-60, as well as several other corridors, were being considered.

9. Transitioning Fleets to Zero-Emissions

WSP Project Leader, Cliff Henke, provided a presentation on this item. WSP shared current projects that are focused on transitioning fleets to zero-emissions given that the California Air Resources Board (CARB) requires California's public transit agencies to gradually transition to 100% zero-emission bus fleets by 2040.

Questions/Discussions:

- A committee member inquired about CNG/RNG and hydrogen fleets. Mr. Henke responded that hydrogen buses have better ranges; however, they do experience problems in extreme climates and extreme elevations. CNG and RNG fleets are currently being considered as potential back-ups in case if the grid malfunctions.

10. 2020 San Gabriel Valley Energy Champion Awards Structure

SGVCOG staff provided a presentation on this item. The SGVCOG proudly introduces the 2020 San Gabriel Valley Energy Champion Awards to recognize San Gabriel Valley cities' efforts for increasing energy efficiency in municipal facilities. San Gabriel Valley cities that meet certain thresholds in municipal and community energy efficiency and community outreach will receive awards and recognition from the SGVCOG.

CHAIR'S REPORT

11. Municipal Best Practice Sharing on COVID-19 Response

Public Works TAC Chair, Rene Guerrero, led the discussion for this item.

Questions/Discussions:

- The City of Pomona shared that City Hall was closed in late March when the Safe-at-Home health orders were announced and that City staff established a schedule to minimize the number of crews that are working. Each City vehicle can only be utilized by one employee at a time. The Pomona City Hall was re-opened for appointments only since June 8th. All employees and visitors must practice physical distancing guidelines.
- The City of Diamond Bar expressed that a re-opening date has not been announced yet; however, temperatures of both employees and members of the public will be taken at city facilities when they re-open. The City recently

conducted a “return-to-work” survey amongst the city employees. Responses included:

- 33% of employees disagreed that they feel confident about returning to work safely full-time in a physical setting.
- 58% of employees strongly agreed that it is important to screen employees with symptoms of COVID-19.
- 48% of employees strongly agreed that they are afraid of carrying the COVID-19 virus back home and infect family members.
- 44% of employees agreed that they are afraid of contracting the virus from co-workers.
- 46.5% of employees strongly agreed that they are afraid of contracting the virus from members of the public.
- The City of Industry shared that split staff schedules have been implemented at City Hall. Temperatures of members of the public will be taken if they are entering City Hall.
- The City of Rosemead also shared that temperatures are being taken for members of the public and employees at city facilities.
- The City of Walnut shared that City Hall has been re-opened since Memorial Day with physical distancing policies in place; however, temperatures are not being taken.

BACKGROUND

The SGVCOG proudly introduced the 2020 San Gabriel Valley Energy Champion Awards in May 2020 to recognize San Gabriel Valley cities' efforts for increasing energy efficiency in municipal facilities. San Gabriel Valley cities that meet certain thresholds in municipal and community energy efficiency and community outreach will receive awards and recognition from the SGVCOG.

Requirements for cities to receive an award include implementing a combination of activities such as attending energy efficiency trainings and meetings, benchmarking all municipal facilities, conducting energy efficiency outreach activities, or reducing energy usage. Cities will be recognized for their achievements in December 2020.

 - Attended 1 Energy Work Group meeting or energy efficiency training in 2020.
 - Benchmarked all municipal facilities and meet with SGVCOG staff to review potential energy efficiency projects.
 - Displayed San Gabriel Valley Energy Wise Partnership marketing materials and SoCalGas rebate/financial incentive materials on the City's website **OR** conducted 1 energy efficiency outreach event with the SGVCOG in 2019 or 2020.
- **Silver Tier**
 - Attended 2 Energy Work Group meetings or energy efficiency trainings in 2020.
 - Benchmarked all municipal facilities and meet with SGVCOG staff to review potential energy efficiency projects.

The SGVCOG is excited to report that the City of South Pasadena recently achieved the Silver Tier. Additionally, the Cities of Alhambra, Arcadia, Diamond Bar, El Monte, Irwindale, Monrovia, Pomona, San Dimas, San Gabriel, South El Monte, and Walnut are close to achieving the Bronze Tier. RECOMMENDED ACTION

BACKGROUND

In August 2017, the SGVCOG was awarded a Greenhouse Gas Reduction Fund Grant in the amount of \$4.554 million by the California Transportation Commission (CTC) to form a bikeshare program in the San Gabriel Valley. The bikeshare program, known as GoSGV, aims to decrease drive alone trips and increase the share of bicycling trips within the San Gabriel Valley, promote and encourage bicycling as a safe and sustainable mode of transportation for short local trips, and expand low-cost transportation options. Ultimately, GoSGV will expand to 840 bikes stationed at bikeshare hubs in 15 jurisdictions in the San Gabriel Valley that had previously provided letters of intent to participate in the regional program.

In 2019, the SGVCOG released a joint request for proposals including all participating cities to procure a sole vendor to implement the e-bike share pilot program for the fifteen participating jurisdictions in the region. The SGVCOG received proposals from six e-bike share companies. Following a review by a technical evaluation committee made up of SGVCOG staff and staff from three participating cities, Gotcha Mobility Holdings, LLC was selected.


Users can unlock bikes using the Gotcha app and will be charged \$2.00 to unlock and 10 cents per minute to ride or an annual flat fee of \$79.99. Qualified low-income riders can pay \$1.00 to unlock and 5 cents per minute to ride or an annual flat fee of \$5.00.


Over the last year, SGVCOG staff has worked with city staff from throughout the region to facilitate the launch of the GoSGV Bikeshare Program. SGVCOG has worked with Gotcha, city staff, and technical experts in bike share station siting to identify the most appropriate locations to place bikeshare hubs, facilitate the adoption of bike share ordinances in participating cities, and develop approaches to expand access to GoSGV for lower-income users.

On July 9, 2020, the City of South El Monte partnered with the SGVCOG to host a kick-off ceremony to announce the official launch of the GoSGV Program. South El Monte launched with an initial outlay of 30 bikes in South El Monte with 5 bikeshare hubs. SGVCOG staff looks forward to working with staff from all participating cities to launch GoSGV across the San Gabriel Valley over the next year. Participating cities include Baldwin Park, Claremont, Covina, El Monte, Monterey Park, South Pasadena, unincorporated areas of Los Angeles County, Pomona, La Verne, and Duarte.

RE: RECOMMENDATION TO THE GOVERNING BOARD TO APPROVE AN ADVANCE/LOAN FOR MSP FUNDING FOR THE I-605 VALLEY BOULEVARD INTERCHANGE IMPROVEMENT PROJECT AND ASSIGNMENT OF THE PROJECT TO THE CAPITAL PROJECTS AND CONSTRUCTION COMMITTEE

RECOMMENDED ACTIONS

Recommend the Governing Board to approve an advance/loan of future Measure M Subregional Programs (MSP) funding for the I-605/Valley Boulevard Interchange Project and assign this project to the Capital Projects and Construction Committee.

SUMMARY

The Los Angeles County Metropolitan Transportation Authority (Metro) is currently preparing the plans and specifications for high priority projects identified in the I-605 hot spot study to improve the I-605/Valley Boulevard interchange. One project will be ready to begin construction in 2022, but unfortunately the construction funding included in the San Gabriel Valley Measure M MSP Highway Efficiency Program is not available until 2048. To allow this project to begin construction in a timely manner, SGVCOG and Metro staff are recommending a loan agreement with Metro of Measure M funding in 2022 to be paid back over the following seven years with future San Gabriel Valley Subregional Measure M MSP fund allocations.

BACKGROUND

As part of the I-605 hot spot study funded under Measure R, several early action projects were identified several years ago. Two of those fell within the SGVCOG's jurisdiction: The I-605/Valley Boulevard Interchange Project, and the SR-60/7th Avenue Interchange Project. The Gateway Cities Council of Governments included funding for the environmental clearance and design of these two projects under their Measure R I-605 hotspot program. Metro was designated the lead agency for this effort and has awarded consultant contracts for the design of both projects. For its part, the SGVCOG included funding in San Gabriel Valley Measure M MSP under the "Highway Efficiency Program" to fund the construction of these projects.

The proposed improvements can be found in Attachment A. For the I-605/Valley Boulevard Interchange Project, the southbound ramps will be re-located, a new signal installed, the RR crossing will be upgraded, and the intersection of Valley Boulevard and Temple Avenue will be improved. For the SR-60/7th Avenue Interchange Project, the westbound 7th Avenue on-ramp will be modified to increase ramp storage capacity to alleviate the traffic impacts to the local streets

and the other ramps will have the geometrics modified horizontally and vertically to alleviate high accidents for these ramps.

The design of these two projects will be completed next year; however, funding availability under the San Gabriel Valley Measure M MSP under the Highway Efficiency Program will not be available until 2048. These projects were ranked as high priority under the I-605 hotspot study and the report indicated significant safety and level of service benefits if these projects could be completed earlier. The SGVCOG and Metro staff have been discussing various options on how to accelerate the construction of these projects in lieu of waiting for funding availability in 2048.

Metro is proposing a potential alternative that involves the ability to borrow against future MSP revenues. Attachment B contains two borrowing scenarios, one where the SGVCOG obligates all of the subregion's upcoming MSP sources (all of our MSP programs) and pays back the debt over four years. The other scenario is paying the debt over a longer period (seven years), thus keeping some of the subregion's MSP funds for programming for local projects.

Note that the SGVCOG will be borrowing funds intended for the Active Transportation, First and Last Mile/Complete Streets, Bus System Improvements, and Highway Demand programs since these are the only SGVCOG MSP programs receiving MSP funding in the first 20 years of Measure M. Depending on the borrowing option chosen, the SGVCOG will have a reduced ability to allocate funding under these programs to our member agencies under a future call for projects. Eventually, these borrowed funds from these programs would be paid back in 2048 when the Highway Efficiency MSP program finally receives funding.

To maintain future call for project funding, yet also able to accelerate this essential highway improvement, SGVCOG staff is recommending that the SGVCOG proceed with the longer term borrowing proposal (identified as the minimum payment option in the attachment) for only the I-605/Valley Boulevard interchange project at this time. This option allows this crucial project to proceed in a timely manner, yet retains MSP funding to allow the SGVCOG to conduct future call for projects. SGVCOG staff believes this project has greater motorist safety and traffic congestion relief benefits.

Metro has indicated that the SGVCOG would be the agency to deliver this project and will be entering into a project agreement similar to the one executed for the 57/60 Confluence Project.

BUDGET IMPACT

To advance the proposed I-605/Valley Boulevard interchange project, the SGVCOG will borrow \$36.9 million in MSP funds in Fiscal Year 2022 and repay the principal over the next seven years with an interest expense of \$4,214,250. Funds will be borrowed from the Active Transportation, First and Last Mile/Complete Streets, Bus System Improvements, and Highway Demand MSP program. Those funds will be reimbursed in full by the Highway Efficiency Program MSP in 2048.

SGVCOG Chief Engineer, Mark Christoffels, will provide a detailed presentation at this meeting.

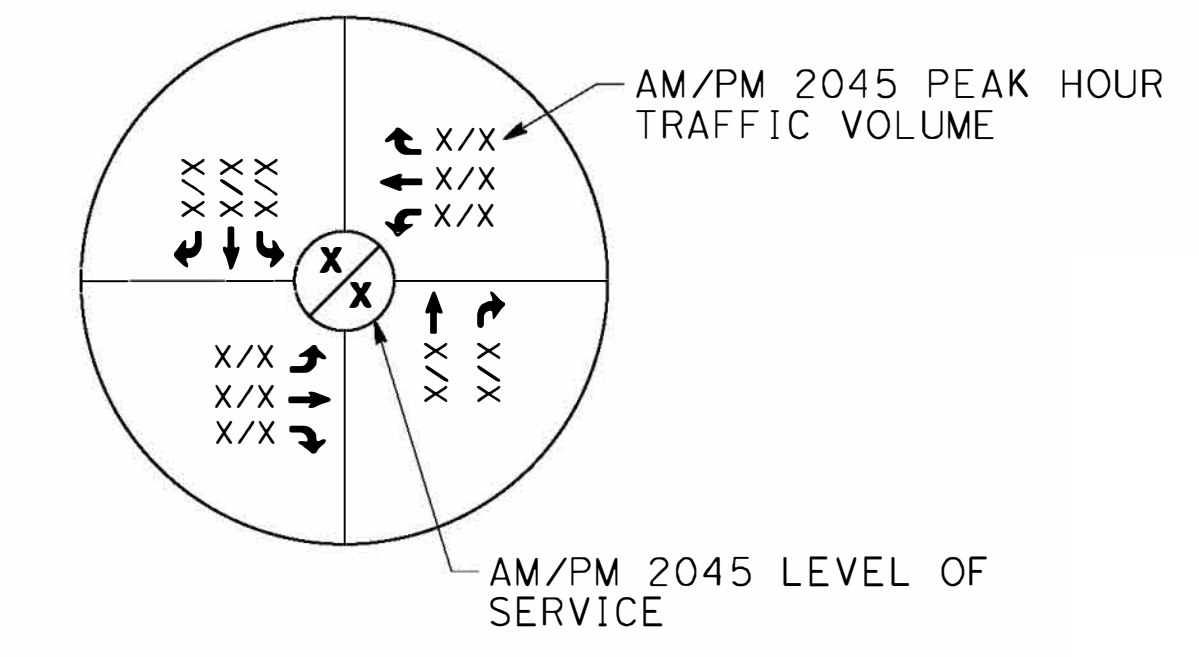

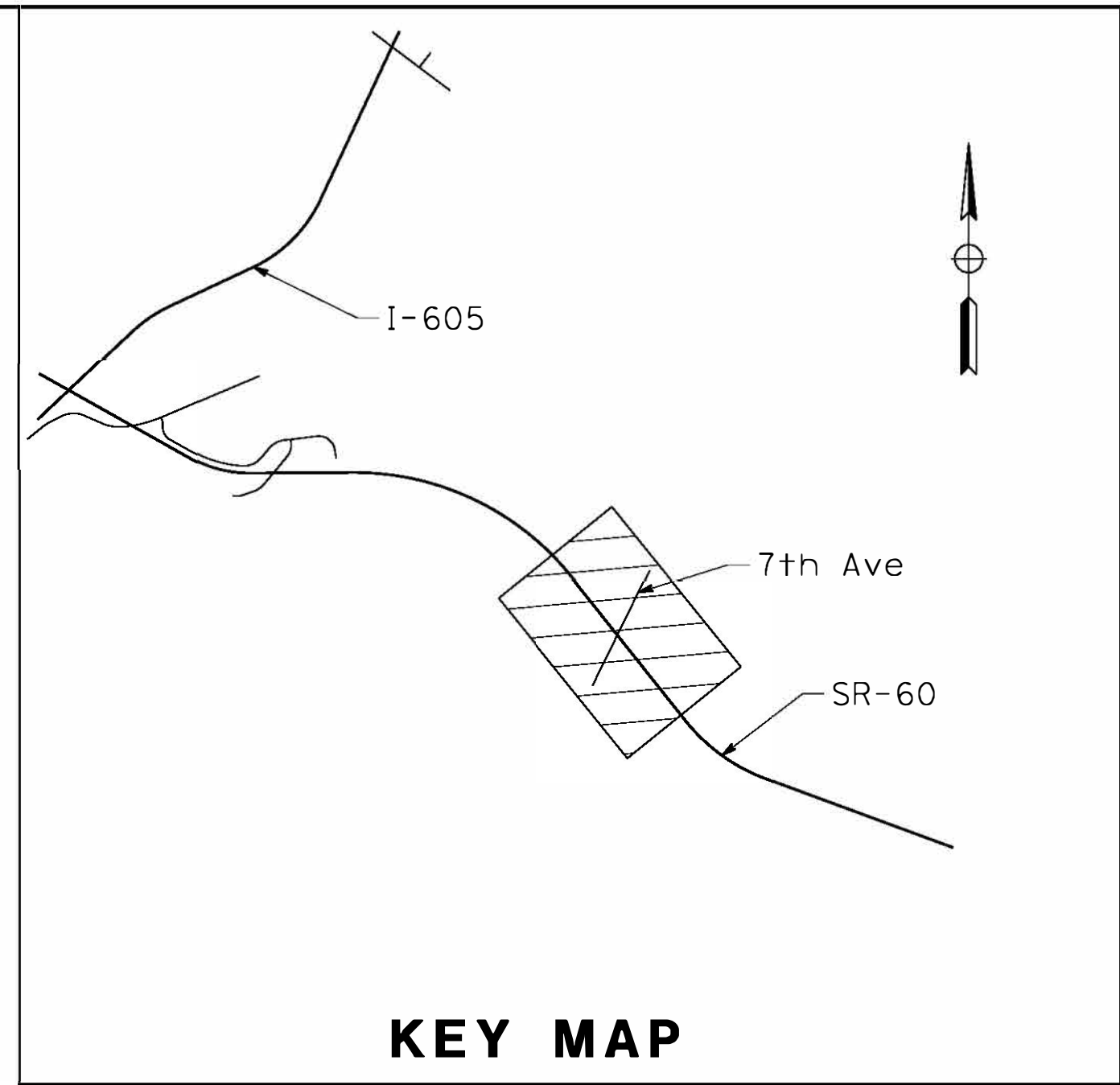
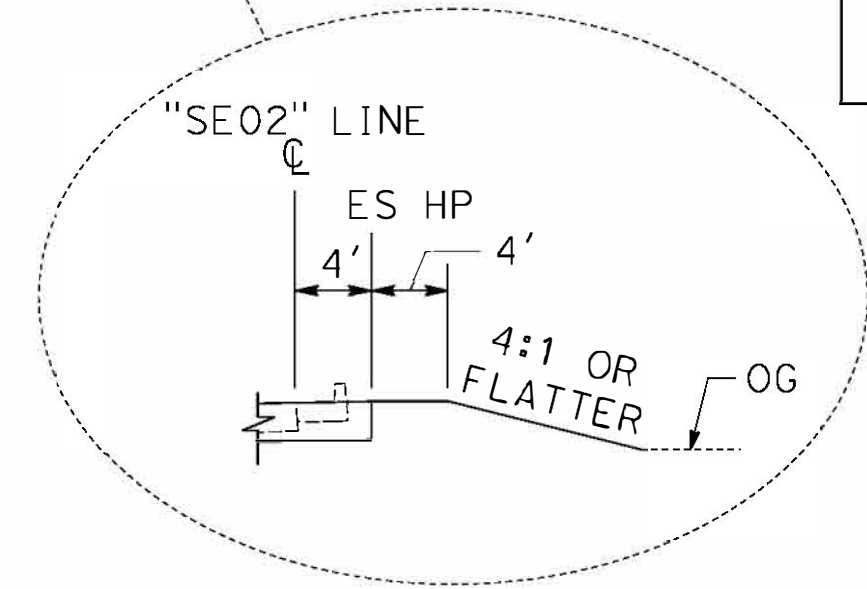
TYPICAL SECTION

SOUTH OF EB OFF-RAMP



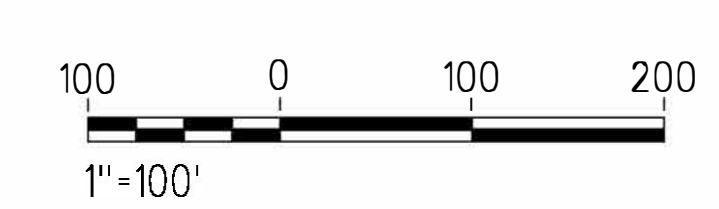
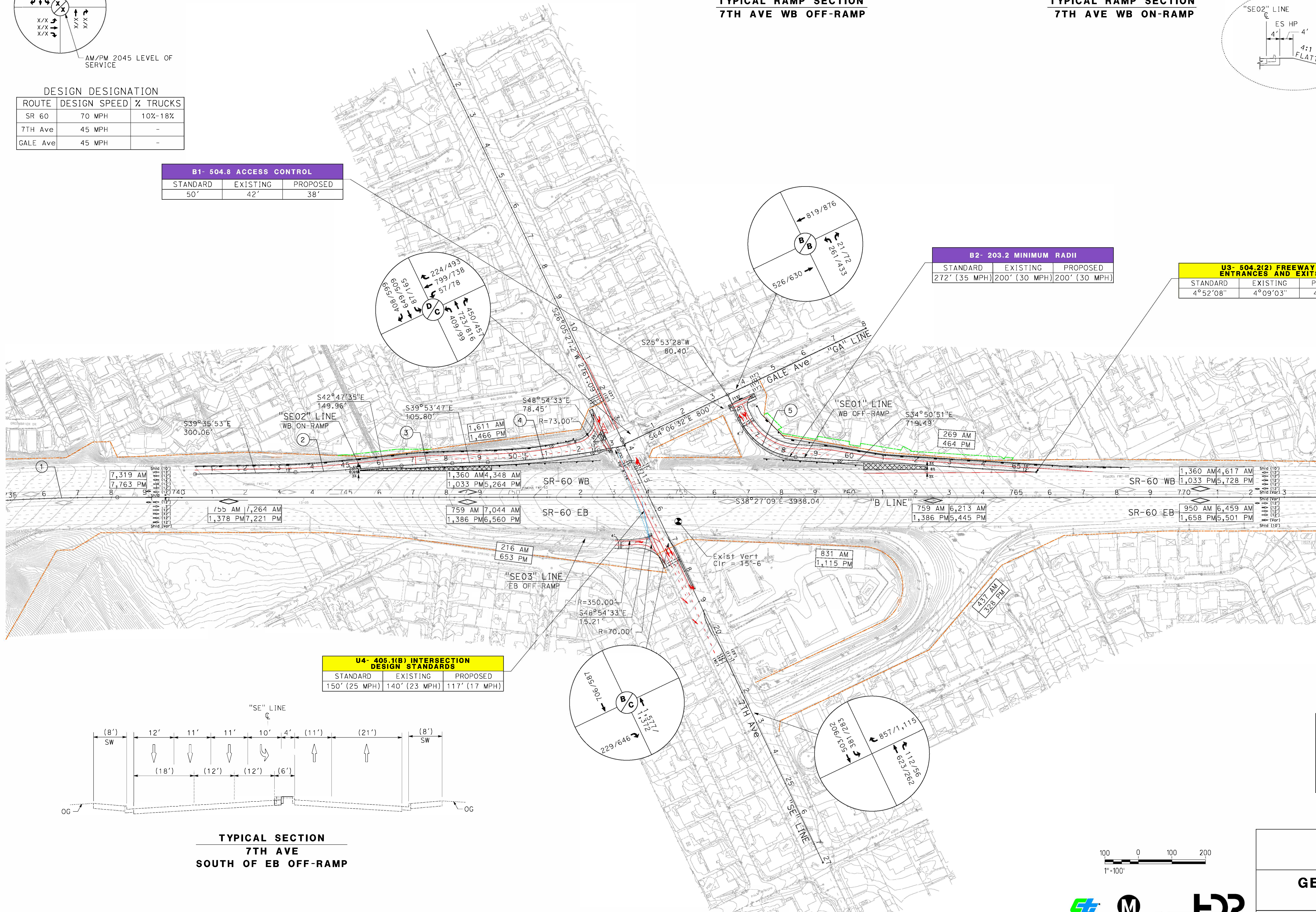
TYPICAL RAMP SECTION
