At a special meeting, the public may only comment on items that are on the agenda. Members of the public are requested to state their name prior to speaking, and comments are limited to a maximum of three minutes per person. The Committee Chair may impose additional time limits if comments become repetitious, an individual member of the public seeks to speak on numerous items, or a large number of members of the public seek to speak on an item. The Committee may not take action on items not on the agenda and is restricted in discussing items on the agenda.

*MEETING MODIFICATIONS DUE TO THE STATE AND LOCAL EMERGENCY RESULTING FROM THE THREAT OF COVID-19: AB 361 (Rivas), signed by California Governor Gavin Newsom on September 16, 2021, authorizes local agencies to hold public meetings via teleconferencing and allows for members of the public to observe and address the meeting telephonically or electronically to promote social distancing due to the state and local emergency resulting from the threat of the Novel Coronavirus (COVID-19).

To follow the new provisions in AB 361 and ensure the safety of Committee Members and staff for the purpose of limiting the risk of COVID-19, in-person public participation at the Energy, Environment, and Natural Resources Committee meeting will not be allowed. RECOMMENDED ACTION

TELECONFERENCING

Adopt Resolution 22-09-EENR making certain findings that the existence of a local and state of emergency in California caused by the ongoing COVID-19 pandemic continues to directly impact the ability of the SGVCOG to hold public meetings safely in-person, thereby necessitating an ability to continue holding meetings via teleconferencing.

BACKGROUND

Introduced by Assemblymember Robert Rivas (D-Hollister) on February 1, 2021, AB 361 codifies portions of Governor Gavin Newsom's existing Ralph M. Brown Act exemptions pertaining to teleconferencing if a local agency issues an emergency finding, and reissues it every 30 days, that it is unsafe to meet in person. Specifically, the Brown Act exemptions include requirements to provide a public teleconference location, to maintain a member quorum within the agency's jurisdiction and to provide for public comment at each teleconference location, such as a private residence. The legislation expires in December 2024. On September 16, 2021, California Governor Gavin Newsom signed AB 361 into law, effective immediately.

A local agency wishing to rely on the provisions of AB 361 must meet one of the following criteria:

- 1. The local agency holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- 2. The local holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- 3. The local agency holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California due to the threat of COVID-19 and shortly thereafter issued Executive Order N-29-20 suspending certain Brown Act provisions relating to teleconferencing as public meetings began to be held online.¹

¹ Similarly, on March 4, 2020, the Los Angeles County Board of Supervisors and Los Angeles County Health Officer declared a local and health emergency due to the threat of COVID-19.



However, this Executive Order expired on September 30, 2021, despite the State of Emergency remaining in place.

The threat that COVID-19 has presented continues to directly impact the ability of the SGVCOG to conduct Governing Board/committee meetings safely in person. Updated guidelines issued by the Centers for Disease Control and Prevention (CDC) and the Los Angeles County Department of Public Health in July and August 2021 advise governmental entities to refrain from conducting indoor meetings and consider moving operations outdoors, where feasible, to prevent transmission. SGVCOG staff finds it has been unable to find a suitable outdoor space with the requisite audio/visual capabilities at which the monthly committee meetings can be held safely. Similarly, an indoor space with sufficient capacity to accommodate safe social distance practices among members, staff, and the public could not be identified.

In order to continue to conduct meetings in a safe manner and to prevent unnecessary COVID-19 exposure to members, staff and the public, staff is recommending that the EENR Committee adopts a resolution making certain findings in order to be able to continue teleconferencing for its meetings.

BACKGROUND

As electric vehicle (EV) technology advances, the electrification of entire fleets of medium and heavy duty vehicles for commercial operations has become more viable. Some key obstacles to widespread adoption include high capital costs, EV model availability, and operational unknowns particularly related to charging. Ensuring an affordable, fast, and easy charging process requires appropriate support from the power grid and dedicated infrastructure, both of which will depend on federal and state funding. SGVCOG member cities can benefit from the cost savings associated with fleet electrification, the opportunity to meet emissions reduction goals, and complying with regulations. It is critical to inform local leaders on the available federal funding sources, the EV procurement and deployment process, anticipated challenges, and the infrastructure investments required for these projects.

TRC is an environmental, engineering, and technology firm that has conducted significant research and analysis work on the topics of energy efficiency, electrification, and distributed energy resources.

Representatives from TRC will provide a detailed presentation on this item.

RECOMMENDED ACTION

BACKGROUND

Starting January 1, 2022, SB 1383 required the State Air Resources Board approve and implement the comprehensive short lived climate pollutant strategy to achieve, from 2013 levels, a 40% reduction in methane, a 40% reduction in hydrofluorocarbon gases, and a 50% reduction in anthropogenic black carbon, by 2030. In order to accomplish these goals, the bill specified that the methane emission reduction goals include targets to reduce the landfill disposal of organic waste 50% by 2020 and 75% by 2025 from the 2014 level. In order to achieve these goals, California's waste management infrastructure is going to have to recycle much higher quantities of organic material.

AB 1985 (Rivas, Robert) would allow a local jurisdiction to procure landfill-diverted recovered organic waste made from California to comply with these recovered organic waste product procurement target requirements. The bill would allow a local jurisdiction, in procuring recovered organic waste products, to utilize California-derived recovered organic waste that is processed outside of the state. Additionally, this bill would require any penalties imposed by the department on a local jurisdiction that fails to meet its recovered organic waste procurement target to be imposed pursuant to a specified schedule based on the percentage of the local jurisdiction's recovered organic waste product procurement target achieved.

DISCUSSION

Like all recycling, organic waste recycling can only succeed if there is a market for the recycled materials. At this time, production of compost and other organic waste products exceeds demand. In order to address this problem, under the direction of SB 1383, CalRecycle has developed a requirement for local governments to procure minimum amounts of organic waste products. AB 1985 (Rivas, Robert) clarifies the procurement regulations and guidelines. This bill seeks to give local jurisdictions flexibility in meeting the ambitious requirements set by SB 1383. One of the key provisions of this bill is to allow jurisdictions to compensate for failing to meet procurement targets by implementing programs designed to reduce waste.

Those in support of this bill assert that it will help local governments in reaching organic waste goals by providing a way to connect with local farmers and community members in need of organic waste products, and expand procurement options for local jurisdictions to provide innovation solutions that will help reach out California's climate goals. However, one concern of this bill is that by allowing local jurisdictions to meet its procurement requirements by purchasing Californian waste that has been processed out of state, it undercuts the goal of building recycling infrastructure in California. Increased infrastructure will be necessary to process all of the organic waste that the state will produce.

AB 1985 has passed in the Assembly and is currently expected to be heard by the Senate Appropriations Committee on August 8, 2022.
