SGVCOG Governing Board Adopts 2022 Strategic Plan Update

The SGVCOG Governing Board voted to adopt the 2022 Strategic Plan Update last month. Based on feedback and input, five strategic goals were incorporated, including transportation, homelessness and housing, water, environment, and collaboration. Each strategic goal has its respective strategies and performance indicators to allow for the implementation and tracking of success for the revised Strategic Plan. Additionally, the Strategic Plan included updates to the agency's Vision Statement, Mission Statement, and Core Values as follows:

- Vision Statement: The SGVCOG will serve as a model subregional government agency is Southern California that is committed to enhancing the quality of life in the San Gabriel Valley by supporting member agency goals, promoting regional collaboration, and delivering exceptional government services, programs, and capital projects across the membership.
- **Mission Statement:** The SGVCOG services as a subregional government agency that maximizes resources and promotes regional and member interests to improve the quality of life in the San Gabriel Valley.
- **Core Values:** Unity of Common Goals & Objectives, Embracing of Diversity, Upholding of Highest Ethical Standards, Collaboration & Mutual Respect, and Fiscal Responsibility

Montebello's Operation Stay Safe: San Gabriel Valley's Second Tiny Homes Shelter

The City of Montebello has partnered with the San Gabriel Valley Regional Housing Trust (SGVRHT) and the SGVCOG to develop a 30-unit Tiny Home site, known as Operation Stay Safe, to provide temporary housing for individuals experiencing homelessness in the City of Montebello. Operation Stay Safe will be the second Tiny Home site in the San Gabriel Valley and is anticipated to open in May 2022.

On-site supportive services will be provided by Volunteers of America Los Angeles. Each resident will gain the safety and stability that comes with having a roof over their head while being connected to permanent housing. The ability to lock a door at night is instantly life-changing as residents can rest without fear of the dangers faced on the streets.
