SGVCOG Hosts Regional Homelessness Summit

On August 1st, the SGVCOG hosted a regionwide Homeless Summit in San Dimas. The Homeless Summit convened nearly 150 city representatives and regional partners. Over the last five months, more than half of the cities in the San Gabriel Valley created homeless plans to address the growing homeless crisis in the regions. This event was a great opportunity to highlight city efforts and build upon the momentum to collectively combat homelessness. The Summit also provided participants tools to help them begin plan implementation.

A highlight of the Summit was the keynote address by LA County Supervisor Hilda Solis who, along with her colleagues, voted to provide funding for cities for their city homeless plans. Additionally, LA County Homeless

Initiative Director, Phil Ansell spoke and provided information on how cities can continue to partner with the County, as they begin the process of implementing their individual plans.

Another featured speaker included, LA County Deputy Sheriff Lt. Geff Deedrick. Lt. Deedrick spoke about how the Sheriff's Department HOST program helps to link individuals to services. This event also featured a cohort discussion, which provided cities an opportunity to talk about collaboration and finding efficiencies to implement their plans.

The SGVCOG's role in facilitating regional coordination events, such as this, has provided cities and regional partners an opportunity to collectively address the homeless crisis in the region. (Cont.)

Board Approves Bike Share RFP for Release:

At the July meeting, the SGVCOG Board approved the release of an RFP to expand bike share in the San Gabriel Valley. This will be funded through a grant of \$4.5 million that was awarded to the COG from the California Transportation Commission. The RFP will look for firms that can provide automated dockless bikes. The selected firm will be tasked with providing a bike share system that will also incorporate technology to allow bicycles to be returned at any existing bike rack or identified bike parking location.

This system will be deployed in 15 cities and include up to 840 bicycles. The fleet will be comprised of 40% pedal assist. Additionally, 50% of the fleet will serve disadvantaged communities. Implementation of the system is expected to begin in Spring 2019, in a phased roll out. This project will now be assigned to the Capital Projects Construction Committee. City Homeless Count Released by LAHSA:

The Los Angeles Homeless Services Authority (LAHSA) recently released the city specific homeless count numbers. In the San Gabriel Valley, the total homeless count was 3,057. These numbers do not include the City of Pasadena, as they conduct their own count. LA County Releases Online tool for Homeless Outreach :

Los Angeles County recently launched a new online platform through which members of the public can notify authorities about homeless issues within their community. This will provide residents a way to assist homeless individuals who may need immediate help.

The portal, known as LA-HOP, allows residents to fill out a quick outreach form requesting help for vulnerable residents living on the street. This platform is funded through Measure H and will be run by the LA County Homeless Initiative and the LA County Health Care Agency. SGVCOG EENR Committee Receives Tour of

The EENR Committee was given a tour of Highway 39 in the San Gabriel National Monument. Caltrans representatives provided the committee an overview of the Highway and discussed the current conditions, issues revolving around reopening the route and various environmental concerns. As it stands now, there are 5 alternatives being considered, as follows:

- **Alternative 1. No Build** – This option would keep the route as is and only necessary maintenance will be conducted along the 4-mile closed section.
- **Alternative 2. Evacuate Route** – This

option is a minimum build option and would only improve the roadway for service vehicles and emergency vehicles. The estimated cost would be between \$17 million and \$22 Million.

- **Alternative 3. Recreation Route** – This option would only reopen the route to pedestrians and bikers, while vehicular access will be strictly limited to shuttle services. The estimated cost would be \$100 Million to \$130 Million.
- **Alternative 4. Full Public Opening** – This option would reopen the closed segment to the public and provide

unrestricted access to through traffic allowing connection to State Route 2. The estimated cost would be between \$110 Million and \$150 Million

- **Alternative 5 Viaduct Construction** – This option would allow for the construction of a 4.4-mile-long viaduct bridge, which would allow wildlife unhindered crossing from below. The estimated cost for this would be between \$400 Million and \$550 Million.

It is anticipated that Caltrans will release their Project Study Report in September.
