

SGVCOG Weekly Recap

Week of December 6, 2021

- **Executive Committee:** On Monday, the Executive Committee held its monthly meeting via Zoom. The Committee received an overview of how the CalPERS termination liability is calculated for CalPERS participating agencies and a recap of the SGVCOG's proactive efforts to minimize risks of participation in the CalPERS system by the establishment of a Section 115 Trust. Additionally, the Committee reviewed and approved the draft December 16 Governing Board agenda.
- **Solid Waste Working Group:** On Monday, the SGVCOG Solid Waste Working Group convened to review CalRecycle's upcoming solid waste grant opportunities and highlight examples of SB 1383 training materials for municipal department directors. Additionally, Working Group members discussed the possibility of expanding the San Gabriel Valley Regional Food Recovery Program. After a thorough discussion, the Working Group expressed interest in continuing the Regional Food Recovery Program's outreach and education efforts beyond February 2022 and adding the implementation of subregional food recovery hubs to the Program's Scope of Work. Staff will develop a preliminary scope to guide the Program's expansion and present the scope for the Working Group's review at the January Solid Waste Working Group meeting.
- **San Gabriel Valley Regional Housing Trust (SGVRHT) Board Meeting:** On Wednesday, the San Gabriel Valley Regional Housing Trust (SGVRHT) Board approved a funding recommendation for an adaptive reuse project in the City of Baldwin Park to create 50 beds of homeless housing for a minimum of two years. The SGVRHT will contribute up to \$25,000 per bed, or up to \$1,250,000, pending the final bed count verification. The City is contributing the land for the project which was recently purchased for \$2,150,000, effectively leveraging at least 1.7 dollars for every dollar contributed by the SGVRHT to develop the site. The City will also contribute the operational costs for the site including the supportive services and ongoing utility costs, further leveraging SGVRHT's investment. Applications will continue to be accepted on a rolling basis and staff are available to assist with the application process. The Application and Letter of Interest to participate in the program are available at sgvrht.org. - **Homelessness Committee:** On Wednesday, the SGVCOG Homelessness Committee convened for its monthly meeting via Zoom. The Committee reviewed the following major items.
 - **2022 Strategic Plan Update:** Following an overview from staff on the accomplishments related to homelessness and housing over the last several years, the Homelessness Committee recommended that the Governing Board approve a new Homelessness and Housing goal for the 2022 Strategic Plan Update that incorporates goals related to housing, mental health, and substance abuse services, to acknowledge the SGVCOG's increased efforts in these areas. This item will be presented to the Governing Board as part of the overall Strategic Plan Update next year.
 - **2022 Legislative Priorities:** Following a presentation on the 2021 accomplishments by SGVCOG staff, the Committee recommended the Governing Board approve the 2022 Legislative Priorities for homelessness. These priorities will be presented to the Governing Board for consideration at their January 2022 meeting.

- **2022 Greater Los Angeles Homeless Count:** Pablo De Lara, SPA 3, Community Relations Coordinator, LAHSA, provided a presentation overview of the 2022 Greater Los Angeles Homeless Count. The Greater Los Angeles Homeless Count is an annual point-in-time (PIT) count that is mandated by the federal Department of Housing and Urban Development (HUD). For the upcoming 2022 count, paper tally sheets will be replaced by the Akido Connect mobile application. This aims to improve data gathering and quality assurance processes. The count for Service Planning Area 3 will take place on Tuesday, January 25, 2022. More information is available at www.theycountwillyou.org.
- **Caltrans and Homeless Coordinating Financing Council Encampment Resolution Grant Program:** Jeffrey Newman, Chief of Staff, Caltrans District 7, provided a presentation on the HCFC Encampment Resolution Grant program and Caltrans collaborations to meet the challenges of homelessness. The objective of the HCFC program is to fund local demonstration projects that provide innovative service delivery models and cross-systems collaborations that support individuals experiencing homelessness in encampments and provide these individuals with a meaningful path to safe and stable housing. He also highlighted the Caltrans District 7 Maintenance Division Policies and Procedures pertaining to the fair and equitable treatment of persons experiencing homelessness (PEH).

The next SGVCOG Homelessness Committee will be held on Wednesday, January 5, from 9-10:00 a.m.

- **Blue Ribbon Commission on Homelessness (BRCH) Meeting:** On Wednesday, staff attended the 8th meeting of the Blue Ribbon Commission on Homelessness (BRCH). The following presentations were made:
 - Colette Langston, Metro Board Clerk, presented an overview of the Los Angeles County Metropolitan Transportation Authority and its governing structure. Additional highlights included Metro Board structure, governance, and meeting overview.
 - Kate Anderson, Director, and Lisa Watson, Consultant of the County of Los Angeles Center for Strategic Partnerships provided a presentation. The Blue Ribbon Commission on Child Welfare Reform made a recommendation to create the center in an effort to prioritize deeper partnerships between the county and philanthropic institutions to improve the child welfare system.
 - Brandon D. Young, Partner at Manatt, Phelps & Phillips, LLP, provided an overview on homeless system funding, with an emphasis on LAHSA's funding obligations and funding sources and Measure H funding process and priorities, and regional coordination and innovation funding.

- **2021 Energy Champion Awards Celebration Event:** On Wednesday, the SGVCOG held its quarterly Energy Work Group Meeting via Zoom. The Energy Work Group celebrated the jurisdictions achievements in the 2021 San Gabriel Valley Energy Champion Awards. Assemblymember Chris Holden, who chairs the Assembly Committee on Utilities and Energy, provided welcoming remarks to congratulate the cities and agencies that have reached recognizable tiers in the 2021 Energy Champion Awards. A total of 10 cities and agencies were highlighted for their energy efficiency accomplishments during the recognition ceremony.

After the recognition ceremony, the SGVCOG staff unveiled the 2022-2023 Energy champion Awards Structure, which can be found [here](#), and encouraged cities and agencies to begin planning on implementing the energy efficiency actions that can qualify for recognition in the 2022-2023 structure. The Energy Work Group is expected to reconvene in February 2022.

- **Homeless Policy Deputies' Meeting:** On Thursday, the Homeless Policy Deputies convened for its biweekly meeting via Microsoft Teams.
 - **PATH LeaseUp/ Resident and Property Supportive Services (RPSS):** Thomas Wong, LAHSA, provided an RPSS Update and shared an overview of active and potential pilot projects and programs that will encourage a more proactive state of unit acquisition. Craig Joyce, PATH, provided a marketing overview of LeaseUp LA including its marketing media plan and marketing toolkit.
 - **Homekey 2.0 Solicitation Update:** Elizabeth Ben-Ishai, CEO-HI, provided an update on solicitation for the 2nd round of Homekey. Homekey 2.0 makes \$360 million in state funding available to jurisdictions within Los Angeles County. In October, an (RSFI) was released to identify co-applicants that will acquire, rehabilitate (as needed), provide property management, and, in some cases, provide supportive services for interim or permanent housing for individuals and families who are experiencing homelessness or who are at risk of homelessness.
 - **LAHSA Prevention and Problem-Solving Update:** Alexandra Brown, LAHSA, provided a Problem-Solving update and overview that focused on intervention, household outcomes, system goals, and data collected over the last 3 fiscal years. James Gilliam, LAHSA, presented prevention system goals, eligibility and program effectiveness.
- **Homeless Working Group:** On Thursday, staff held its monthly homelessness working group meeting via Zoom. There was an overview from SGVCOG staff on the upcoming 2022-23 Measure H programs - including the gaps in services program that will focus on supplementing existing services and resources to best serve the region, the hard to reach program, which will focus on providing intensive support and services to those individuals who need the most assistance in transitioning into housing, and the mobile alternative crisis response program. Staff from the City of Montebello also provided an overview of the City's homelessness programs. The next meeting will be held on Thursday, January 27, 2022, at 10:00 a.m.
- **Transportation Committee:** On Thursday, the SGVCOG Transportation Committee convened via Zoom for its monthly meeting. The Committee reviewed the following major items:
 - **FY 2022-2025 Measure M Multi-Year Subregional Program (MSP) Active Transportation, Bus System Improvements, and First/Last Mile Programming Recommendations:** The Committee reviewed staff's recommendations for the Governing Board to program \$15,000,000.00 from FY 2022-2025 MSP Active Transportation, Bus System Improvements, and First/Last Mile Funds for the East San Gabriel Valley Sustainable Multimodal Improvement Project and directed staff to work with cities and agencies that submitted applications for Category 2 to refine project scopes that can lead to improvements that would provide regional benefits to the San Gabriel Valley's active transportation, bus system, and first/last mile networks.

- **SGVCOG Strategic Plan Update:** The previous comprehensive update to the SGVCOG Strategic Plan was adopted in March 2019. The Strategic Plan serves as a roadmap for the agency and identifies the priorities and actions that the agency undertakes. As this year concludes, staff propose to update the Strategic Plan to identify priorities and actions that are more relevant for the agency to undertake to support member agencies. - **Metro Transit Fare Collection Resumption:** To keep riders and employees safe, Metro suspended front door boarding on buses in March 2020 as a result of the COVID-19 Pandemic. Metro also relaxed rules and policies requiring riders to use the farebox and TAP validator. With vaccinations well underway and mask-wearing policies instilled in Metro's transit system, Metro will resume front-door boarding and restart fare collection beginning January 10, 2022. Bus riders will be required to board at the front of the bus and pay their fares. Additionally, train riders will be required to tap the electronic card reader at turnstiles or down at the station platforms. To ease riders into paying, the Metro Board of Directors approved several temporary discounts, including a 50% discount on fare charges via passes through July 20, 2022. Metro Low Income Fare is Easy (LIFE) Program members will also receive additional discounts through July 20, 2022. Under a 23-month Fareless Systems Initiative (FSI) Pilot Program that was previously approved by the Metro Board, K-12 and community college students from participating schools and college districts can ride free. Students must activate their new TAP cards to receive free rides under the FSI.
- **Wildlife Management Roundtable:** On Thursday, the SGVCOG held a Wildlife Management Roundtable with city staff and California Department of Fish and Wildlife (CDFW) representatives to discuss the possible expansion of the SGVCOG's Neighborhood Coyote Program. SGVCOG staff provided an overview of the Neighborhood Coyote Program and presented on the similarities and differences between coyote management and wildlife management strategies. After a thorough discussion, attending cities recommended staff to revise the current Regional Coyote Management Framework and Neighborhood Coyote Program to include general wildlife management outreach strategies. The revised plans will be presented to the SGVCOG City Managers' Steering Committee for review and feedback in Spring 2022. Once approved, the plans will be presented to the SGVCOG Governing Board for adoption.
- **Redistricting Update (State/Federal):** The California Citizens Redistricting Commission (CRC) met this week to revise the statewide maps for Assembly and Congressional districts. During these meetings, the Commission conducted live line-drawings and received public input on the draft maps. The Commission developed a final draft of the Assembly map and advised that subsequent changes to the Assembly map would have to wait until the revisions to the Congressional and Senate plans are made in the next two work-weeks. Currently, the Commission is deliberating the Congressional map, and, starting the week of 12/13, the Commission will revise the Senate map. The Commission will have a few days beginning December 18, 2021, to revisit all the map revisions they've made in the preceding weeks since Thanksgiving before settling on final plans they will need to certify before the court-ordered December 27, 2021, deadline.

- **Redistricting Update (County):** The LA County Citizens Redistricting Commission met on Tuesday for their fourth and final Public Hearing, as well as on Wednesday for their Regular Meeting. At the public hearing, comments varied mostly between two of the three final map options: Map F2 and Map B3. At their regular meeting on Wednesday, the CRC presented tweaks to maps F2 and B3 that they worked on in their ad hoc committees. Those two have been taken up as the *new* final map considerations, now titled F3 and B4. Their next meeting is scheduled for today, Friday, December 10 at 1:00pm. They may have another meeting on Saturday, December 11 at 9:00am; however, it is currently listed as *tentative*. They are formally scheduled to meet again on Sunday, December 12 at 3:00pm. The meetings on Friday, Saturday, and Sunday are scheduled in order for the CRC to continue tweaking and narrowing down the final two map options with the goal of finalizing a final, single map option. The CRC's final meeting is on Wednesday, December 15 at 5:00pm. At this final meeting, the CRC aims to formally adopt the final LA County Supervisorial map. The state deadline to adopt this map is Wednesday, December 15 at 11:59pm.
- **Launch of Newsletter by Metro Board Director Tim Sandoval:** This week, Tim Sandoval, LA Metro Board Director, launched the first edition of his new quarterly newsletter related to updates on LA Metro's capital projects, programs and initiatives of significance to cities, residents and businesses in the San Gabriel Valley. - **Governing Board Preview:** The SGVCOG Governing Board will hold its monthly meeting next Thursday, December 16, 2021 at 4PM via Zoom Teleconference. The full agenda packet may be accessed at <https://www.sgvcog.org/governing-board-agenda>. Major action items are summarized below:
 - **Updated Salary Resolution:** Staff is recommending updating the SGVCOG salary resolution to update the manager classification so that all manager positions are under a single classification regardless of assigned department or position. The specific responsibilities and subject matter of the manager would be described in the position description, which would allow for more flexibility in terms of the subject matter overseen by each manager as responsibilities change over time. Compensation for these manager positions will remain unchanged by this update.
 - **Amendment to Alameda Corridor-East (ACE) Projects Measure R Agreement:** Staff is recommending authorizing the Executive Director to execute an amendment to the Measure R Master Agreement with Metro for the ACE projects. Metro and the SGVCOG entered into a Measure R Master Funding Agreement on June 14, 2013 pertaining to \$358,000,000 programmed for the ACE Phase II projects. The agreement includes a working capital loan from the ACE Measure R funds in the amount of \$45,000,000 to support the SGVCOG with its cash flow needs as it relates to the delivery of the ACE Projects. In anticipation of lower cash flow needs, the SGVCOG recently remitted to Metro \$15,000,000 in partial repayment of the total working capital loan, leaving a balance of \$30,000,000. In preparation for the repayment, SGVCOG staff requested a restructuring of the loan terms and conditions to accommodate the loan pre-payment, to extend the loan term an additional three years to accommodate lengthened project delivery schedules and to make other adjustments to allow for future pre-payments. As a practice, Metro has withheld as collateral the equivalent of five-thirds (5/3) of the current outstanding loan balance. This withheld amount was previously set at \$75,000,000 and under the lower balance and current amendment will be reset at \$50,000,000, freeing up \$25,000,000 for project implementation needs. In

- September 2021, the Metro Board of Directors approved this proposed amendment to the Measure R agreement.
- **Metro Open and Slow Streets Grant Program Agreements:** On December 2, 2021, the Metro Board of Directors approved the Cycle 4 Open and Slow Streets Grant Program funding allocations. Open and slow streets are events which temporarily close the streets to automobiles and open them up to people to re-imagine their streets while walking, riding a bicycle, rollerblading or pushing a stroller in a car-free environment. The SGVCOG received approval from the Metro Board for the following events and staff is recommending authorizing the Executive Director to negotiate and execute the following agreements with Metro:
 - Agreement for an amount up to \$396,000 with Metro to undertake the 626 Golden Streets/Mission-to-Mission open streets event on May 1, 2022;
 - Agreement for an amount up to \$496,000 with Metro to undertake the 626 Golden Streets/ArroyoFest open streets event on October 30, 2022;
 - Agreement for an amount up to \$500,000 with Metro to undertake the Heart of the Foothills open streets event in April 2023; and
 - Agreement for an amount up to \$500,000 with Metro to undertake the SGV Slow Street Demonstration Initiative through January 2022 to December 2023.
 - **Governing Board Stipends:** The SGVCOG has an adopted resolution that issues a \$75 stipend for attendance at regular, special or emergency meetings for Governing Board Delegate and Alternate Governing Board Representatives. According to the adopted stipend resolution, the total stipend amounts shall not exceed \$900 per fiscal year for each member agency Governing Board representative. The amount is based on the Governing Board representative attending 12 meetings in a fiscal year. Given that the Governing Board held two special meetings this year, in addition to holding regular meetings each month, staff is proposing to increase the total stipend amount per member agency to \$1,275 to accommodate these special meetings. Additionally, increasing this total amount will account for the need to hold additional special meetings as a result of the requirements of AB 361 (Rivas), which requires that resolutions reaffirming the State of Emergency due to the ongoing COVID-19 pandemic be approved every 30 days for Brown Act public meetings to continue meeting via teleconference.

Week of December 13, 2021

- **Capital Projects and Construction Committee:** On Monday, the SGVCOG Capital Projects and Construction Committee convened for its monthly meeting via Zoom. The Committee approved the adoption of Resolution 21-03-CPCC, making specified findings to enable the Capital Projects and Construction Committee to continue to hold meetings via teleconferencing. The Committee took action on the following items:
 - 2022 Capital Projects, Construction and Transportation Legislative Priorities;
 - Agreement number 21-30 with National Railroad Safety Services, Inc. for railroad flagging services;
 - Task Order 02 No. 02 with WSP USA for construction management services;
 - Utility relocation Agreement with Southern California Edison for the State Route 57/60 Chokepoint Relief Program Phase 1 – Diamond Bar Golf Course Project;
 - Task Order No. 4, Revision 16 for final design with Moffat & Nichol for the Montebello Corridor Grade Separation Project;
 - Task Order No. 3 Revision 9 with Moffatt & Nichol for Final Design: At-Grade Crossing Safety Improvements For The Montebello Corridor Grade Separation Project;
 - Approval of the Committee meeting schedule for calendar year 2022 and the January 24, 2022 Meeting Format.

The Committee also reviewed and took action on the preview of the hearings to consider resolutions of necessity for parcels for the State Route 57/60 Confluence Chokepoint Relief Project in The City Of Diamond Bar.

- **Blue Ribbon Commission on Homelessness (BRCH) Meeting:** On Wednesday, staff attended the 9th meeting of the Blue Ribbon Commission on Homelessness (BRCH). The following presentations were made:
 - Stephanie Klasky-Gamer, President and Chief Executive Officer and Kris Freed, Chief Programs Officer from LA Family Housing provided a presentation overview of their role as a lead homeless service provider in SPA 2, in addition to the range of housing and service models they provide. They also provided recommendations to improve the homeless services system in LA County, such as improved data infrastructure and coalitions throughout the region that are consistent, action-oriented, and operate with a collective vision.
 - Wesley G. Beverlin, Partner, Lewis Brisbois Bisgaard & Smith LLP and general counsel for the LA County Sanitation Districts provided a presentation overview on the public agency's role, structure and responsibilities.
 - Pastor Eddie Anderson, McCarty Memorial Christian Church provided a presentation emphasizing the work faith-based organizations are doing to address homelessness and the challenges that they face in their efforts.
 - There was a discussion amongst Commissioners to speak on the roles of the Los Angeles Homeless Services Authority (LAHSA) and what changes should be made. A main point of agreement between Commissioners is that LAHSA currently has too many responsibilities and is involved in too much to operate successfully. In deviating from its original design and purpose, changes are necessary for LAHSA to be able efficiently serve its role.

- **SGV Transit Feasibility Study TAC Meeting:** On Wednesday, the SGVCOG convened the San Gabriel Valley Transit Feasibility Study Technical Advisory Committee to present the Study's initial 15 conceptual alternatives and provide updates on the Study's technical and outreach progresses to date. The 15 alternatives were proposed to include east-west concepts, north-south concepts, and bus/rail hybrid concepts. Additionally, staff announced the launch of the Study's [webpage](#) and community input [survey](#). The TAC is anticipated to reconvene in February 2022 to review the proposed concept's ridership and cost estimates data. Updates regarding the Study will also be presented to the SGVCOG Public Works Technical Advisory Committee and the SGVCOG Planning Directors' Technical Advisory Committee next month.
- **Broadband Roundtable:** On Wednesday, the SGVCOG held a Broadband Roundtable to present the SGVCOG Broadband 101 Guide, which includes updates on the County of Los Angeles' broadband expansion efforts, the SGVCOG's existing broadband involvements, and existing funding sources. Attendees also shared their municipal broadband needs and perspectives on the County's broadband efforts. Overall, attendees recommended the SGVCOG continue providing relevant broadband updates to member agencies and advocating for funding for San Gabriel Valley cities to conduct a regional broadband needs assessment. The Broadband 101 Guide will also be presented to the SGVCOG Public Works Technical Advisory Committee next month.
- **EENR Committee:** On Wednesday, the SGVCOG Energy, Environment, and Natural Resources (EENR) Committee convened via Zoom for its monthly meeting. The Committee received a presentation from the Metropolitan Water District of Southern California (MWD) on its Regional Recycled Water Program (RRWP). The Program will purify wastewater to produce high-quality water that could be used again. Once completed, the RRWP can become one of the largest advanced water treatment plants in the world. The Committee is scheduled to reconvene on Wednesday, January 19, 2022 at 1:00pm.
- **LA County Redistricting:** On Wednesday, the County of Los Angeles Citizens Redistricting Commission held its final meeting and adopted a new LA County Supervisorial Map. While most SGVCOG member cities will remain in the same district, the following changes will occur:
 - Alhambra and San Gabriel move from District 5 to District 1;
 - Diamond Bar moves from District 4 to District 1;
 - Claremont moves from District 1 to District 5, and
 - The City of La Verne was split between Districts 1 and 5 in order to keep the Fairplex in one district.

The new map is now in effect and will remain so until the next Census takes place in 2030. To view the entire map and see what District your city is in, [click here](#).

- **Governing Board Recap:** On Thursday, December 16, 2021 the SGVCOG Governing Board held its monthly meeting via Zoom. A summary of the major action items are summarized below:
 - **Updated Salary Resolution:** The Governing Board voted to approve Resolution 21-51 updating the SGVCOG salary resolution. The update changes the manager classification so that all manager positions are under a single classification regardless of assigned department or position.
 - **Amendment to Alameda Corridor-East (ACE) Projects Measure R Agreement:** Members of the Governing Board voted to authorize the Executive Director to execute an amendment to the Measure R Master Agreement with Metro for the ACE projects.
 - **Metro Open and Slow Streets Grant Program Agreements:** The Governing Board voted to authorize the Executive Director to negotiate and execute the

following agreements for implementation of the Open Streets and Slow Streets Projects:

- Agreement for an amount up to \$396,000 with Metro to undertake the 626 Golden Streets/Mission-to-Mission open streets event on May 1, 2022;
 - Agreement for an amount up to \$496,000 with Metro to undertake the 626 Golden Streets/ArroyoFest open streets event on October 30, 2022;
 - Agreement for an amount up to \$500,000 with Metro to undertake the Heart of the Foothills open streets event in April 2023; and
 - Agreement for an amount up to \$500,000 with Metro to undertake the SGV Slow Street Demonstration Initiative through January 2022 to December 2023.
- **Governing Board Stipends:** Members of the Governing Board voted to adopt Resolution 21-52 to update the total stipend amounts per member agency for Governing Board meetings. Given that the Governing Board held two special meetings this year, in addition to holding regular meetings each month, the total stipend amount per member agency is now \$1,275 to accommodate these special meetings. Additionally, increasing this total amount will account for the need to hold additional special meetings as a result of the requirements of AB 361 (Rivas).
- **Statewide Redistricting:** This week, the California Citizens Redistricting Commission (CRC) met to finalize the Congressional and Senate maps. No major decisions were made at this meeting, as the CRC decided to delay big decisions, such as making additional changes to the future House seats. As the CRC works through the Senate maps, they will reserve time at the beginning of each meeting to discuss changes to the Congressional maps. Regarding the Senate maps, the CRC first met on Tuesday to discuss the maps and will continue to make revisions until the end of this week. CRC Chairman J. Ray Kennedy's goal is to complete the line-drawing process by Monday, December 20 so that the CRC can review its final report by Thursday, December 23. A three-day review period coupled with the state's Christmas holiday makes the 23rd the last day for Commission actions before the CRC can certify the full redistricting plan in time for the court-ordered Dec. 27 deadline. - **State/Federal Redistricting:** On Monday, the California Citizens Redistricting Commission (CRC) voted unanimously to approve the next decade's maps for Congress, State Senate, Assembly, and the Board of Equalization. There will be a few procedural actions before the Commission certifies these district maps as law by December 27, but the CRC will not make any further changes to the adopted maps. Given the new maps, the SGV's congressional and statewide districts shift from 6 Congressional districts to 5 districts, 8 Assembly districts to 6 districts, and 5 Senate districts to 3 districts.
