RE: FOOTHILL TRANSIT BUS STOP ENHANCEMENT PROGRAM

RECOMMENDED ACTION

BACKGROUND

Foothill Transit developed the Bus Stop Enhancement Program (BSEP) to offer financial assistance to member cities, class pass participating colleges, counties, and the state for improving bus stops serviced by Foothill Transit. The program provides up to \$40,000 per project, reimbursing applicants after project completion. Its goals are to enhance safety, upgrade current transit amenities, improve bus stop technology, strengthen community identity, and attract new transit users.

Participation in this program would help improve the comfort, safety, and appeal of local transit facilities while supporting broader community and transportation goals. Eligible improvements include but are not limited to:

- Shelters and benches (without advertising)
- Trash cans
- Real-time arrival signage
- Solar lights
- Bike racks
- Tree grates
- Bus pads (only when combined with other improvements)

To apply, entities must submit a detailed application that includes a cover letter, current bus stop conditions, improvement descriptions, plans and photos, an estimated cost breakdown, and a construction timeline. Applicants must also comply with all federal procurement and construction guidelines and meet Foothill Transit's contract and subrecipient requirements.

RE: CAPITAL PROJECTS UPDATE

BACKGROUND

The Alameda Corridor-East (ACE) Construction Authority was established in 1998 by the San Gabriel Valley Council of Governments (SGVCOG) as a single-purpose construction authority. ACE's main focus has been to implement a construction program that mitigates vehicle delays and collisions at rail-roadway crossings resulting from growing freight rail traffic in the San Gabriel Valley. In 2017, the SGVCOG was restructured and established the SGVCOG Capital Projects and Construction Committee, as a successor to the ACE Construction Authority with full responsibility for implementing the ACE Project.

The ACE Project is a comprehensive program of constructing grade separations, where the road goes over or under the railroad, at 19 crossings (resulting in the elimination of 23 at-grade crossings) and safety and mobility upgrades at 53 crossings. Construction has been completed on fourteen rail-roadway grade separations. Three grade separations are under construction with another two grade separations and eight crossing safety projects in the design phase. Jump Start safety improvements have been completed at 40 at-grade crossings.

In recent years, SGVCOG's staff of engineers, project management support staff, accountants, auditors, and outreach specialists have also begun developing and implementing other capital improvement projects to benefit member agencies in the San Gabriel Valley. These include the SR 57/60 Confluence Chokepoint Relief Project, the I-605 at Valley Blvd. Improvements Project, active transportation and first-last mile projects that will complement new Metro A Line stations, and the Bus Corridor Transit Improvements Project. SGVCOG is seeking to maximize the benefit of its construction authority to help realize significant projects for our member agencies.

Kevin Lai, SGVCOG Director of Capital Projects, and project management staff will provide an update on current and upcoming projects.
