Governing Board Convenes In-Person Meeting



For the first time since 2020, the SGVCOG Governing Board met in person and also convened at our new office in Monrovia! On March 22nd, over 31 member cities, two Supervisorial districts, and three water districts held a board meeting to conduct the business of improving the quality of life in the San Gabriel Valley. It was a new milestone for the SGVCOG and a real pleasure to see everyone

together in our new space. Below is a brief summary of what took place at the meeting:

- The Board authorized a sole-source contract with Fehr & Peers to update the Vehicle Miles Traveled (VMT) Model and Tool for the SGVCOG and its 27 member cities.
- The Board also authorized amendments to the Workforce Development service provider contracts, allowing Goodwill Industries of Southern California and God's Pantry to pay wages to Workforce Development program participants. The Board authorized the SGVCOG to submit its 2023-24 Local Solutions Fund application, proposing funding allocations and guidelines for programs that prevent homelessness and directly house client



- Additionally, the Board authorized an agreement with Jensen Hughes to develop the San Gabriel Valley Community Wildfire Protection Plan. SGVCOG received a CAL FIRE grant totaling \$677,959 in 2022 to develop this program.
- The Board also approved an additional allocation of \$100,000 and any unspent funds from other 2022-23 Homeless Programs to the Housing Linkage Working Group. Finally, the Board approved several internal and external appointments and received a presentation on the LifeArk Tyler Project in El Monte. The project creates safe, sustainable, and affordable homes for people living in low-income, marginalized communities around the world, and LifeArk Tyler is the first project to provide permanent supportive housing and ongoing intensive case management services.

We hope to see you at our next Governing Board meeting scheduled for April 20th. All regular Governing Board meetings are held on the third Thursday of each month at 4:00 PM in the SGVCOG Board Room of our office (1333 S. Mayflower Ave, Suite 360, Monrovia, CA 91016).

SGVCOG Presents Montebello Corridor Grade Separation Project at City Council Meeting



The San Gabriel Valley Council of Governments (SGVCOG) presented an update on the Montebello Corridor Grade Separation Project at the Montebello City Council meeting on March 22nd. The proposed project aims to improve safety and reduce traffic congestion by eliminating crossing collisions and upgrading crossing safety enhancement measures, among other benefits.

Montebello's crossings are traversed by an average of 49 trains per day, resulting in 10 collisions and three fatalities in recent years. The Montebello Corridor Grade Separation Project seeks to address the safety concerns of the current at-grade crossings by constructing a roadway underpass and railroad bridges on Montebello Blvd. and pedestrian crossing safety enhancements at the Greenwood Avenue, Maple Avenue, and Vail Avenue. The project will also install medians at the Greenwood Avenue and Vail Avenue crossings to prevent vehicle drive-arounds, further improving safety.

Additionally, the project will reduce traffic congestion and vehicle emissions. Without the project, growing train and vehicle traffic would result in a doubling of vehicle hours of delay at the busiest crossing, Montebello Boulevard, which carries an average of 21,000 vehicles per day. This is a critical infrastructure investment that will significantly benefit the residents of Montebello and the San Gabriel Valley.

Thanks to the City of Montebello for allowing us to share how this vital project will benefit their residents during the meeting. The SGVCOG is committed to keeping the City and its residents informed throughout the process and we are grateful for their support. We're proud to be bringing this project to the city and look forward to working together.

Southern California Waste Management Forum Spring Conference Presentation

RHCCC members were excited to hear about the proposed alternatives and had plenty of questions and feedback to share.

A week later, on March 20th, SGVCOG staff presented the same findings of the Transit Feasibility Study to the Hacienda Heights Improvement Association (HHIA). SGVCOG wanted to gather feedback from residents about the study and the proposed routes. SGVCOG staff members enjoyed answering residents' questions and taking in their comments.

SGVCOG is committed to making transportation options more accessible and sustainable for all residents of the San Gabriel Valley region. We are excited about the potential for the transit feasibility study to be a game-changer for transit and mobility in the area. The team looks forward to continued feedback and collaboration with the community as we work towards a more connected future.

Serenity Homes Receives Best of the Best Award



On March 16th, Serenity Homes, the family interim housing site in Baldwin Park, was recognized as a model program by the California Parks Recreation Society (CPRS) District 13 (San Gabriel Valley Region).
