On September 20, 2023, the San Gabriel Valley Council of Governments (SGVCOG) released the Housing Solutions Fund Application. The Housing Solutions Fund provides additional assistance to cities and services providers with direct costs related to housing, rehousing, and stabilizing clients who are either at-risk or experiencing homelessness in the San Gabriel Valley. Some examples of eligible costs include rental assistance, motel vouchers, security deposit assistance, and move in costs.
