6. Review Public Works TAC Meeting Minutes: 10/21/2019

PRESENTATIONS

7. Solid Waste Legislation Review and Updates
Los Angeles County Department of Public Works Management Assistant, Elijah Carder, provided a summary of solid waste legislation that were introduced in this year’s legislative cycle. Additionally, Mr. Carder mentioned that the department would closely monitor two-year bills that are related to solid waste, such as AB 1080 (Bloom)/SB 54 (Allen) and AB 1509 (Mullin).

Discussions/Questions:

- Representatives from the Los Angeles County Department of Public Works solicited feedback regarding the department’s existing legislative outreach efforts. Committee members mentioned that these legislative presentations are informative and helpful to local jurisdictions; however, committee members recommended that these legislative presentations should be provided during the legislative session to allow cities the opportunities to submit position letters on various bills.

8. Job Order Contracting
SGVCOG Project Manager, Edward Villanueva, and Gordian Representative, Michael Celesta, provided an overview of the process of utilizing job order contracting (JOC). Mr. Villanueva expressed that SGVCOG intends to explore the use of JOC to aid in-project delivery and facility repairs throughout the San Gabriel Valley region. As a

result, a pilot program was proposed for San Gabriel Valley cities that are interested in utilizing JOC.

Discussions/Questions:

- A committee member inquired about the process of awarding the contracts. Mr. Celesta responded that the consultant would set up the process and that the participating city would be the entity that awards the contract.
- Another committee member inquired about the need to amend municipal codes in order to utilize JOC. Mr. Celesta mentioned that each local jurisdiction varies from one another and that codes can be further examined to determine the need for amendments.
- A member of the public inquired about JOC partnerships with other councils of governments (COGs). Mr. Celesta responded that his team is currently exploring partnerships with other COGs given that Gordian traditionally partners with cities and counties.

After a thorough discussion, committee members recommended this item be re-visited at the next meeting for a possible recommendation for the SGVCOG City Managers' Steering Committee to review the JOC process and the proposed pilot program.

DISCUSSION ITEMS

9. SB 743 Implementation & San Gabriel Valley Regional Transportation Analysis Model
SGVCOG Chief Engineer, Mark Christoffels, provided a presentation on SB 743 (Steinberg), which was approved by former Governor Brown in 2013 to change the focus of transportation impact analysis in CEQA from measuring impacts to drivers to measuring the impact of driving. Specifically, the change replaced level of service (LOS) with vehicle miles of travel (VMT). Cities must adopt the new VMT measurements by July 1, 2020. Additionally, Mr. Christoffels mentioned the effectiveness of cities combining efforts to establish regional VMT analysis models and cited examples from the Western Riverside Council of Governments and cities in northern Orange County. The estimated cost of developing a VMT analysis model for the San Gabriel Valley region is approximately \$200,000.

Discussions/Questions:

- A committee member inquired whether the County of Los Angeles had explored the idea of developing a regional VMT analysis model. Mr. Christoffels expressed that he has not heard of such an endeavor by the County.
- Most committee members verbally expressed interest in participating in the development of a VMT analysis model for the San Gabriel Valley region.

Committee members recommended this item be re-visited at the next meeting for further discussion and suggested Mr. Christoffels to solicit interest and feedback from the SGVCOG Planning Directors' Technical Advisory Committee at its upcoming meeting on Thursday, December 5, 2019.

10. Potential Tour: ACE Construction Project Sites

Several committee members expressed interest in touring grade separation construction sites of the Alameda Corridor-East (ACE) Project in early 2020.

RE: **EFFECTIVE PUBLIC OUTREACH STRATEGIES FOR PUBLIC WORKS PROJECTS**

RECOMMENDED ACTION

BACKGROUND

Given that public works projects directly affect numerous residents and neighborhoods within municipalities, including a public information component in the initial planning stages can enhance project success by identifying key components that the public is concerned about. Additionally, this strategy can reduce work zone impacts by providing specific project information to the travelling residents.

Benefits of incorporating an effective public outreach strategy within a public works project include:

- Improving the public's awareness and understanding of the project;
- Promoting project support within the community; and,
- Alerting the public about potential traffic impacts and providing alternative travel options.

SGVCOG's Alameda Corridor-East (ACE) Project, which focuses on constructing grade separations and pedestrian crossing improvements, currently has a comprehensive public outreach model that engages members of the public regarding ACE construction projects.

The model includes components such as publishing project fact sheets and construction notices on various media and public engagement channels, conducting a local business support program to assist affected businesses during project construction, issuing mailers to nearby residents, and implementing a school safety outreach program for schools near construction projects.

SGVCOG staff members will provide a brief presentation on the ACE public outreach strategies.

ABOUT THE SOUTH BAY CITIES COUNCIL OF GOVERNMENTS

The South Bay Cities Council of Governments (SBCCOG) is a joint powers authority of 16 cities and the County of Los Angeles that aims to maximize the quality of life and productivity of the South Bay region. The agency focuses on addressing regional issues such as water, energy, transportation, homelessness, and air quality. Additional information regarding the SBCCOG can be found on <http://www.southbaycities.org/>.

BACKGROUND

SBCCOG partnered with the South Bay Workforce Investment Board (SBWIB) to develop a regional broadband fiber-optic network. A high-speed capacity broadband network can allow cities to embrace the digital economy and attract businesses in the South Bay region. As more businesses are transacted online, broadband has become an increasingly important component to equip local businesses with the services they need to compete and thrive in the digital economy.

Through funding from the SBWIB, the SBCCOG developed a fiber-optic master plan to address the feasibility of a regional broadband network that would connect to at least one city facility in each of the South Bay cities. In October 2019, the SBCCOG Board of Directors officially approved the South Bay Fiber Network and received a list of sites committed to participating. Deployment of the network is expected to begin early this year.

Aaron Baum, SBCCOG Project Manager, will provide a detailed presentation regarding the South Bay Fiber Network at this meeting.

SUBJECT: TRANSMITTAL OF A STAFF WORKING PROPOSAL OF THE REGIONAL PHASE I MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PERMIT

The California Regional Water Quality Control Board, Los Angeles Region (Los Angeles Water Board or Board) is transmitting to you a staff working proposal of the Regional MS4 Permit, including the Order and Attachments A-E and G-S. This staff working proposal is for preliminary review and discussion purposes only. In distributing this staff working proposal, please be advised of the following.

This staff working proposal does not constitute either a “draft permit” or a “proposed permit” as defined in Title 40 Code of Federal Regulations (40 CFR) sections 122.2 or 124.6. Further, distribution of this staff working proposal for review and discussion does not constitute a public comment period pursuant to 40 CFR sections 124.10 or 124.17.

Los Angeles Water Board staff encourages input on this staff working proposal. Permittees and interested persons are invited to discuss comments with Los Angeles Water Board staff in future in-person meetings and/or conference calls. Comments may also be made at upcoming Board meetings and public workshops. In particular, we encourage you to review the staff working proposal and be prepared to share your input at a workshop in early January 2020. We will send details regarding the workshop once they are finalized.

For those who wish to submit written comments, they may be submitted by e-mail to MS4StormwaterRB4@waterboards.ca.gov. Note, however, that the Los Angeles Water Board will not be formally responding to written comments on the staff working proposal. When a “draft permit” is released pursuant to 40 CFR sections 124.10 or 124.17, Permittees and interested persons will be provided an opportunity to submit written comments; consistent with federal regulations, staff will prepare responses to significant comments received on the draft permit submitted in compliance with the public notice.

If a Permittee or interested person finds that its oral or written comments provided on this staff working proposal are not addressed in the draft permit, the Permittee or interested person will need to resubmit the written comments during the official written comment period for the Board to further consider such comments.
