EMPOWERMENT (CARE) COURT IMPLEMENTATION UPDATE

RECOMMENDED ACTION

BACKGROUND

The Community Assistance, Recovery, and Empowerment (CARE) Act is a 2022 California law that provides community-based behavioral health services to individuals living with schizophrenia spectrum or other psychotic disorders, provided that they meet certain health and safety criteria. It is designed to provide an upstream intervention for individuals experiencing schizophrenia or other psychotic disorders, to avoid psychiatric hospitalizations, incarceration, and conservatorships. Through the CARE Court process, certain people – including family members, first responders, and providers – may file a petition to the court to create a volunteer CARE agreement or court-ordered care plan for the client. The CARE agreement or CARE plan may include treatment, housing resources, and/or other services. There is no involuntary mental health treatment provided through CARE Court, and it is a voluntary program for the individual.

In order to be eligible for CARE Court, an individual must meet the following criteria:

- 18 years or older, with a diagnosis of Schizophrenia Spectrum or Other Psychotic Disorders;
- Have symptoms that are severe in degree and persistent in duration, which may cause behavioral functioning that interferes with a individuals activities of daily living and which may result in an inability to maintain independent functioning without treatment, support, and rehabilitation for a long time;
- Not stabilized with ongoing voluntary outpatient treatment;
- Not likely to survive safely/independently in the community and the condition is deteriorating OR services and support are needed to prevent relapse or deterioration;
- Participation in CARE Court is the least restrictive alternative; and
- Would benefit from participating in a CARE plan or CARE agreement.

Each county is responsible for the implementation of its own CARE Court program. In Los Angeles County, the Department of Mental Health (LACDMH) is responsible for implementation. Implementation in LA County began on December 1, 2023. The County's Program assists people with untreated schizophrenia and other associated psychotic disorders to receive treatment and services aimed at improving their health and well-being, with the goal to redirect eligible participants from jails and emergency rooms to key supportive services that comprehensively address their needs.



Services available to participants include counseling, medication, housing options, social services, and others. Behavioral health professionals conduct the initial assessments and provide support for court updates, as well as monitor the individual's progress. Participants are also assigned an attorney to help navigate the court process and ensure their rights and best interests are protected. Following the determination that the individual is deemed eligible for CARE, a CARE team made up of clinicians, case managers, and people with lived experience create a personalized treatment plan. Participants receive services for up to one year, which the court can renew for an additional year if necessary, following the one-year status hearing. Even after participants are no longer in the CARE program, they may still continue with treatment, supportive services, and housing options to support long-term recovery.

RE: LA COUNTY FY 26-27 MEASURE A SPENDING PLAN

RECOMMENDED ACTION

BACKGROUND

In November 2025, the new County Department of Homeless Services and Housing released its draft expenditure plan for the FY 2026-27 Measure A funding. The Expenditure Plan also included various other homelessness funding sources. The draft plan can be found here.

The County was facing a budget deficit of approximately \$300 million, due to the end of several one-time funding sources, increased interim housing costs for County-managed sites, and reduced anticipated tax receipts. This meant that the County needed to identify reductions in its proposed services. To do that, the County established a set of criteria and a phased review process in order to evaluate funded programs and make recommendations for the proposed funding reductions. The County completed the first phase of its evaluation in October 2025, making initial recommendations for funding curtailments. That initial review identified approximately \$30 million in proposed funding curtailments. Following that initial evaluation, the County completed a program-level review of the remaining programs to identify the remaining funding curtailments needed to address the budget deficit. Unfortunately, the resulting budget will likely result in a reduction in homelessness services across the County. An overview of the proposed Plan and potential impacts – as presented at the Executive Committee for Regional Homeless Alignment (ECRHA) meeting on November 21, 2025 – here.

The public comment period is currently open through December 5, 2025, for the proposed FY 2026-27 Measure A Expenditure Plan. Staff will present a high-level overview of the County's proposed Expenditure Plan and lead a high-level discussion about these proposals.

RE: RENTER PROTECTION AND HOMELESSNESS PREVENTION

(RPHP) IMPLEMENTATION UPDATE

RECOMMENDED ACTION

For information only.

BACKGROUND

In November 2024, Measure A was passed by Los Angeles County voters, authorizing a half-cent countywide tax to address housing and homelessness on an ongoing basis. 35.75% of the collected Measure A funds are allocated to the Los Angeles County Affordable Housing Solutions Agency (LACAHSA) for the production of affordable housing and for renter protection and homelessness prevention. In its FY 2025-26 Expenditure Plan, LACAHSA has allocated this Measure A funding as follows:

- Production, Preservation, & Ownership (PPO) (60% of allocated funds): Eligible uses include new construction (including substantial rehabilitation), preservation, acquisition, rehabilitation, ownership, and rent and operating subsidies.
- Renter Protection and Homelessness Prevention (RPHP) Programs (30% of allocated funds): Designed to help renters of lower income households (less than 80% of area median income) and eligible uses can include but are not limited to intake and assessment; legal assistance and tenant outreach; emergency rental assistance; short-term income support; flexible financial assistance; and relocation assistance (beyond that which is required by State or local law).
- Designated LACAHSA "Annual Priorities" (15% of allocated funds);
- Technical Assistance, Research, and Policy Development (TA) (5% of allocated funds): Eligible uses include local agency technical assistance grants; direct programming; program design, administration, monitoring, and evaluation; and professional services.
- LACAHSA Administration (5% of allocated funds).

Per its enabling legislation, LACAHSA is required to allocate 70% of its allocated funds within the PPO, RPHP, and TA funding categories to the "Eligible Jurisdictions" that are defined in the LACAHSA-enabling legislation. The San Gabriel Valley Council of Governments (SGVCOG) is one of these Eligible Jurisdictions and is responsible for administering LACAHSA funds on behalf of 30 of the 31 cities in the San Gabriel Valley. The LACAHSA Board of Directors adopted guidelines and requirements for Eligible Jurisdictions' use of PPO, RPHP, and TA Funding.



At its May 2025 meeting, the Governing Board took actions authorizing the execution of agreements and other activities associated with the release of applications for the SGVCOG's PPO, RPHP, and TA LACAHSA funding. To implement the PPO Program, the SGVCOG will contract with the San Gabriel Valley Regional Housing Trust (SGVRHT). To implement the RPHP Program, the SGVCOG will subcontract with multiple service providers. For the RPHP Program, the SGVCOG anticipates receiving approximately \$8.5 million, pending sales tax receipts.

DISCUSSION

In the month of October, the SGVCOG released an application to identify RPHP implementation partners. The application was distributed to all of the existing Housing Solutions Fund (HSF) partners, the San Gabriel Valley Consortium on Homelessness – for distribution to its members – and to other partners that the SGVCOG was aware are working in this space. The goal of this application process was to identify partners that could help the SGVCOG quickly establish a comprehensive renter protection and homelessness prevention program that complies with all LACAHSA RPHP guidelines and that advances an integrated, accessible, regional approach. Applications were due on October 31, 2025, and the SGVCOG staff reviewed them to select initial partners.

LACAHSA has released robust guidelines for the implementation of RPHP programs, and there will also be complications in ensuring that all services and partners are closely coordinated. To that end, the first phase of the SGVCOG's process is to initiate a planning process with its implementation partners. The SGVCOG will hold weekly planning meetings with its implementation partners to design a coordinated approach grounded in equity, accessibility, and early intervention aimed at addressing housing instability, reducing evictions and displacement, and preventing people from falling into homelessness. These sessions will use best practices and service provider expertise to build an implementation approach that complies with the LACAHSA RPHP Guidelines and best serves persons at-risk of homelessness in the San Gabriel Valley. Sessions will focus on building approaches for eligibility verification, referral pathways, funding restrictions, service provision, and service capacity. By the conclusion of the planning period, the SGVCOG will have a clear Implementation Plan to implement its RPHP Program. The Planning process began in late November 2025 and is anticipated to be completed in late January 2026. The goal is to begin RPHP Program services shortly thereafter.

A more robust overview of the Planning process and the SGVCOG's RPHP Implementation approach will be provided at the January 2026 Homelessness Committee meeting.

REGIONAL HOUSING TRUST UPDATE

SGVRHT Celebrates 5 Years

On November 12th, the SGVRHT celebrated 5 years with a luncheon. Since its formation in 2020, the SGVRHT has funded 927 units of affordable housing and 130 units of interim housing. These units represent a lasting impact on thousands of lives as individuals and families move into their permanent residences and end their experiences with street homelessness. The commemorative luncheon was hosted at Quiet Cannon in the City of Montebello, which has been an active participant in the SGVRHT. Representatives from SGVRHT's 25 member cities joined the SGVRHT Board of Directors, state and federal elected leaders, affordable housing developers, supportive service providers, lenders, and other partners in celebrating the SGVRHT's accomplishments. SGVRHT chair Jed Leano presented Housing Advocate Awards to Senator Susan Rubio and Congresswoman Judy Chu for their dedication to securing significant affordable housing funding for the region, including more than \$30 million in State funding and \$8 million in federal funding. Senator Rubio, Assemblymembers Blanca Rubio, John Harabedian, and Mike Fong also provided remarks demonstrating their ongoing support and thanking the cities they represent for their dedication to providing housing to vulnerable populations.

SGVRHT Board Meeting

The SGVRHT Board of Directors met for a special meeting on December 1, 2025. The Board voted to approve Revolving Loan Fund (RLF) allocations and an update to the annual administrative dues, and discussed an update to the Board member appointment process. The Board also voted to approve changes to the SGVRHT Notice of Funding Availability (NOFA) process and funding requirements to align with requirements for funding from the Los Angeles County Affordable Housing Solutions Agency (LACAHSA). These changes include an increase in the per unit funding maximum and the addition of labor requirements.

Subject: Report for the December 3 Meeting of the Homelessness

Committee

This memorandum provides an update to the SGVCOG's Homelessness Committee as it relates to LACAHSA's activities and prospective items in December. This update includes the deposited revenues in the SGVCOG's accounts, the notice of funding availability (NOFA) for production, preservation, and ownership (PPO), and the request for proposals related to renter protection and homelessness prevention (RPHP).

MEASURE A REVENUE

Measure A revenue provided to LACAHSA for affordable housing production, renter protection/homelessness prevention, and technical assistance are shared between Eligible Jurisdictions (EJs) and LACAHSA, where 70 percent of revenues support EJ-directed projects and programs and 30 percent of revenues support LACAHSA-directed projects and programs.

LACAHSA has created separate accounts for each EJ to track revenue collection and allocation. Table 1 provides details regarding the monthly allocation and the aggregate amounts available to the SGVCOG as of November 17. SGVCOG has submitted all budget documents, and we look forward to working with and supporting the COG's programs.

Key criteria includes affordability per subsidy dollar advantage to the project with the greatest affordability (as measured by discount to market per bedroom) per dollar of LACAHSA support (including all LACAHSA capital sources); lowest total development cost (by Unit Type Advantage to the project with total development cost per square foot representing the greatest discount to the LACAHSA Unit Cost Standards); and greatest readiness.

The Investment Review Committee will meet on December 4 and 12 to finalize the NOFA with a target date for applications due at the end of January 2026 for respondents.

RENTER PROTECTION AND HOMELESSNESS PREVENTION (RPHP)

Providing resources for people, including children and families, in need of help for renter protection or to prevent their homelessness is central to LACAHSA's mission. The Transitional Guidelines define eligible uses as emergency rental and flexible financial assistance; temporary rental assistance; short-term income support; legal services and renter education; and marketing (i.e., making resources known), assessment, eligibility, and referral services.

There are two active strategies underway:

Firstly, in the short term, LACAHSA has made available funds to existing continue renter protection and homelessness prevention programs. This includes funding to support the stability of Department of Consumer and Business Affairs-funded eviction defense legal services (\$2 million), operated by the Stay Housed LA Collaborative, as well as nine months of funding to support the County's Chief Executive Office's Homelessness Initiative funded network of homelessness prevention and legal services programs (\$11.4 million). By statute, these funds are not permitted to support people who are experiencing homelessness.

Secondly, the FY 25-26 Request for Proposal for Emergency Rental and Flexible Financial Assistance closed on Wednesday, November 19. The Board has approved a budget of up to \$11,469,967 available from LACAHSA's discretionary Measure A funds for this RFP. This funding is expected to be expended between February 2026 and June 30, 2027. As a part of the RFP process, bidders will include the number of people served in their proposal submitted. RFP evaluation criteria includes: organizational capacity and experience (e.g. relevant qualifications; overall capabilities of organization and subcontractors to meet required service levels described in this RFP); geographic reach and ability to serve underserved communities across the County; demonstration of a clear,

Housing Justice Organizer Interim Citizens Oversight Chair realistic and effective approach to delivering proposed services; and budget and cost effectiveness. LACAHSA received 34 applications totally \$108 million in requests, an over subscription of 842 percent above available funds.

Additionally, LACAHSA has heard from various jurisdictions expressing concern with the expenditure timeline for RPHP funds due either to (a) standing up programs and contracting with providers will take time, or (b) that EJs are interested in participating in the Integrated Service Model (ISM) now being designed. Consequently, LACAHSA provided three paths forward to support resources for people:

- 1. Participate in LACAHSA's Request for Proposals (RFP): LACAHSA invites EJs to participate in LACAHSA's financial assistance RFP that has been released. Under this option, a jurisdiction can allocate funding they want to spend on Emergency Rental and Flexible Financial Assistance to LACAHSA. LACAHSA would administer those funds for the jurisdiction and would ensure any assistance goes to households in the jurisdiction. If a jurisdiction is interested in doing this, they need to notify LACAHSA by December 1. This RFP is only for financial assistance, and a jurisdiction would need to determine how to meet the 20 percent minimum required investment in legal services (as adopted by the Board after feedback from EJs). LACAHSA staff are available to assist jurisdictions should they have questions.
- 2. Participate in Integrated Service Model (ISM): Jurisdictions have the option of waiting until the ISM is up and running and then allocating their FY25-26 funds to the ISM. Since the ISM will be operational at the beginning of the next fiscal year (FY26-27), and the expenditure timeline for RPHP funds is 12 months from the date a jurisdiction's budget is approved by LACAHSA, the ISM should be operational before the end of the expenditure timeline for FY25-26 funds. LACAHSA will prioritize spending down a jurisdiction's FY25-26 funds through the ISM during the initial months of ISM's operations,

3. Obligate their funds in FY 26-27: Jurisdictions can choose to stand up programs and have 12 months to expend FY 25-26 funds from the date of approval of their annual budget. A jurisdiction is not required by the Guidelines to have spent down their funds by the end of the fiscal year, but rather within 12 months of their budget being approved.

Consistent with the adopted Transitional Guidelines, EJs will provide quarterly reports on expenditures and programmatic outcomes. First and third quarter reports are financial; second and fourth quarter reports are programmatic.

LACAHSA is grateful to the San Gabriel Valley COG for issuing their RFP related to RPHP and for notifying applicants, being the one of the first among COGs to do so.
