

## SGV CARE: Proposition 47 Funded Housing Program Application

The San Gabriel Valley Crisis Assistance Response & Engagement Program (SGV CARE) was established by the San Gabriel Valley Council of Governments (SGVCOG) as a mobile crisis program and is expanding it's scope to including a housing component. Funding is provided through the Proposition 47 Grant Program whose target audience are clients who have been <u>previously arrested or charged with a misdemeanor or felony</u>. Clients without these *priors* would not be eligible to receive housing support through this program. We are looking to be able to provide housing for at least seven (7) individuals with previous criminal justice interventions. Housing services could include:

- 1. Master lease of an apartment unit(s), home(s), or motel room(s);
- 2. Scattered interim housing sites; OR
- 3. Other projects that provide consistent access to housing units on a longer-term basis.

SGVCOG is looking for a cost effective way to maximize the number of residents housed and will consider awarding multiple service providers depending what is submitted. Referrals for this housing support will be made by SGVCOG contracted service providers: God's Pantry & Sycamores. The selected service provider(s) is expected to work in close coordination with both of those existing providers. God's Pantry & Sycamores are providing recidivism reduction services services (RRS). This application is seeking to identify a partner to provide housing services for clients enrolled in RRS. Applicants are encouraged to think through approaches to coordinating referrals and helping to support clients while they're receiving RRS. RRS services include:

- Intensive Case Management
- Mental Health Support & SUD Treatment
- Legal Aid: expungements, housing disputes, family law, etc.
- Tattoo Removal (God's Pantry)
- Court-Appointment Classes: anger management, parenting, etc.
- Education: GED's and other diploma's
- Family Reunification
- Workforce Development & Job Training

Finally, the selected service provider is expected to help coordinate quarterly reports that the SGVCOG must submit quarterly to the Board of State and Community Corrections (BSCC) which administers the Prop 47 Grant.

## **SCORING:**

- 20% Experience/Background: does the agency have a prior record of securing housing and housing clients quickly.
- 50% Proposed Project Budget: is the proposal cost effective and constitute a fair cost/bed/night rate.
- 30% Project Narrative: does the proposal find innovative solutions for housing clients with priors, get them stabilized, and ultimately connected with permanent housing.
