RE: ADOPTION OF RESOLUTION 21-01-EENR ENABLING THE EENR

COMMITTEE TO CONTINUE HOLDING MEETINGS VIA

TELECONFERENCING

RECOMMENDED ACTION

Adopt Resolution 21-01-EENR making certain findings that the existence of a local and state of emergency in California caused by the ongoing COVID-19 pandemic continues to directly impact the ability of the SGVCOG to hold public meetings safely in-person, thereby necessitating an ability to continue holding meetings via teleconferencing.

BACKGROUND

Introduced by Assemblymember Robert Rivas (D-Hollister) on February 1, 2021, AB 361 codifies portions of Governor Gavin Newsom's existing Ralph M. Brown Act exemptions pertaining to teleconferencing if a local agency issues an emergency finding, and reissues it every 30 days, that it is unsafe to meet in person. Specifically, the Brown Act exemptions include requirements to provide a public teleconference location, to maintain a member quorum within the agency's jurisdiction and to provide for public comment at each teleconference location, such as a private residence. The legislation expires in December 2024. On September 16, 2021, California Governor Gavin Newsom signed AB 361 into law, effective immediately.

A local agency wishing to rely on the provisions of AB 361 must meet one of the following criteria:

- 1. The local agency holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- 2. The local holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- 3. The local agency holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California due to the threat of COVID-19 and shortly thereafter issued Executive Order N-29-20 suspending certain Brown Act provisions relating to teleconferencing as public meetings began to be held online.¹

¹ Similarly, on March 4, 2020, the Los Angeles County Board of Supervisors and Los Angeles County Health Officer declared a local and health emergency due to the threat of COVID-19.



However, this Executive Order expired on September 30, 2021, despite the State of Emergency remaining in place.

The threat that COVID-19 has presented continues to directly impact the ability of the SGVCOG to conduct Governing Board/committee meetings safely in person. Updated guidelines issued by the Centers for Disease Control and Prevention (CDC) and the Los Angeles County Department of Public Health in July and August 2021 advise governmental entities to refrain from conducting indoor meetings and consider moving operations outdoors, where feasible, to prevent transmission. SGVCOG staff finds it has been unable to find a suitable outdoor space with the requisite audio/visual capabilities at which the monthly committee meetings can be held safely. Similarly, an indoor space with sufficient capacity to accommodate safe social distance practices among members, staff, and the public could not be identified.

In order to continue to conduct meetings in a safe manner and to prevent unnecessary COVID-19 exposure to members, staff and the public, staff is recommending that the EENR Committee adopts Resolution 21-01-EENR making certain findings in order to be able to continue teleconferencing for its meetings.

PRESENTATIONS

15. SoCalGas Public Direct Install Program

Synergy Companies Senior Project Manager, Brian Fronk, provided a presentation on this item. In partnership with Synergy Companies, SoCalGas offers the Public Direct Install Program to provide no-cost furnace and water heating optimization measures and incentives for upgrading to high-efficiency furnaces and tankless water heaters. The Program offers various incentives and rebates and provides no-cost offerings such as low-flow showerheads, hot water heater tank insulation, pipe wraps, and low-flow pre-rinse spray nozzles.

Key Discussions/Questions:

- D. Bertone inquired about whether residents can access the benefits of the Public Direct Install Program. Mr. Fronk responded that the Program only applies to municipal facilities. SoCalGas provides other energy programs for residential customers.
- M. Clark commented that tankless water heaters can conserve water usage compared to regular water heaters. Mr. Fronk agreed with Ms. Clark's comments and responded that the residential programs are being advertised in the community.
- 16. Quemetco Battery Recycling Facility Overview

Velada Consulting Senior Vice President, Paulina Velasco, provided a presentation on this item. Quemetco is a battery recycling facility that employs 210 full-time local union workers in the City of Industry. The facility recycles 10 million batteries and generates approximately 120,000 tons of recycled lead every year. Approximately 85% of the lead refined at the facility derives from spent lead-acid automotive batteries. Quemetco recently launched a robust community engagement program and is currently offering virtual tours to interested elected officials, city staff, residents, and community stakeholders.

Key Discussions/Questions:

- D. Bertone inquired about whether all batteries are recycled. Ms. Velasco responded that a battery's recyclability depends on its components. Most batteries can be recycled as long as their lead are removed.
- M. Clark expressed interest in touring the Quemetco facility.

17. Los Angeles County Climate Vulnerability Assessment

Los Angeles County Chief Sustainability Office City Liaison, Liz Crosson, provided a presentation on this item. Developed by the Los Angeles County Chief Sustainability Office, the Los Angeles County Climate Vulnerability Assessment (CVA) examined the physical and social vulnerability of communities to climate impacts such as extreme heat, extreme precipitation, wildfire, sea level rise, drought, and flooding.

Key Discussions/Questions:

- D. Bertone inquired whether the CVA services are mostly informational. Ms. Crosson responded that the County of Los Angeles plans on partnering with cities to provide climate adaptation technical assistance programs.
- D. Bertone inquired whether the goal of the CVA is to influence legislation. Ms. Crosson responded that the County hopes to communicate communities that are at risk in Los Angeles County and provide funding opportunities through the CVA.
- J. Stark inquired about climate vulnerability assessments in cities' hazard mitigation plans. Ms. Crosson responded that vulnerability assessments are mandated in cities' hazard mitigation plans.

18. Wildfire Prevention Planning in the San Gabriel Valley

GGA Architects Principal, Greg Kochanowski, provided a presentation on this item. To improve stewardship in the wildland urban interface, the Fire Safe Alliance was formed as a collaboration of public agencies, departments, and communities to identify solutions and resources for property owners and land managers. The Alliance encourages local jurisdictions to participate or lead efforts to develop a Community Wildfire Protection Plan, which guides future actions of private landowners, local Fire Safe Councils, land management agencies, and emergency service providers wanting to take proactive steps to minimize risks and protect local communities.

Key Discussions/Questions:

• J. Stark recommended this presentation be also provide to the San Gabriel Mountains Community Collaborative.

RE: COVID-19 UPDATES FROM THE LOS ANGELES COUNTY

DEPARTMENT OF PUBLIC HEALTH

RECOMMENDED ACTION

For information only.

BACKGROUND

Currently, the Los Angeles County Department of Public Health (DPH) reports over 1,000 daily positive COVID-19 cases on average. While over 77% of Los Angeles County residents who are eligible to receive vaccines are partially vaccinated, cities and communities should continue to promote the importance of vaccination. Vaccination lowers the chance of an individual getting sick from COVID-19 and prevents spread to others.

Starting October 7th, the County of Los Angeles requires all attendees (ages 12+) to show proof of full vaccination or negative COVID-19 test results prior to entering outdoor and indoor mega events. Additionally, the County requires all indoor bars, breweries, wineries, distilleries, nightclubs, and lounges to verify COVID-19 vaccination status of patrons and employees beginning October 7th. Restaurants are also recommended to reserve and prioritize indoor seating and services for those who are fully vaccinated against COVID-19. Masks will continue to be required in all indoor public settings, venues, gatherings, and businesses, regardless of vaccination status.

As the flu season approaches, all individuals over 6 months and older are recommended to receive flu shots, which can decrease stress on the County's healthcare system. In addition, all individuals should continue to wear a well-fitting mask and stay 6 feet apart when required, wash hands often, and stay home when feeling sick to prevent further spread of COVID-19.

DPH San Gabriel Valley Regional Health Officer, Noel Bazini-Barakat, RN, MSN, MPH, will provide a detailed presentation on this item.

BACKGROUND

Earlier this year, the SGVCOG launched the 2021 San Gabriel Valley Energy Champion Awards to encourage San Gabriel Valley cities and agencies to implement energy efficiency actions and engage in long-term energy planning activities. Requirements for cities and agencies to receive an award include implementing a combination of activities such as attending energy efficiency trainings and meetings, benchmarking municipal facilities, and conducting energy efficiency outreach activities.

Requirements for the Energy Champion Awards are separated into four separate categories as follows:

- Collaborate with the SGVCOG, SoCalGas, and the SoCalREN to benchmark all facilities on Energy Star Portfolio Manager or host a Comparative Energy Analysis meeting with the SGVCOG in 2021.
- Conduct at least 1 municipal facility audit in 2021.
- Participate in the SoCalGas Direct Install Program.
- Participate in one of the following SoCalREN programs to install a gas project: Metered Savings Program, Revolving Savings Fund, and Pathway to Zero.
- Install a gas energy efficiency project in 2020 or 2021.
- Complete or update an Energy Action Plan.
- Submit an energy efficiency grant application.

Jurisdictions have most of the year to complete the necessary requirements to reach the highest tier. Requirements in the "Benchmarking, Audits, and Projects" Category must be completed by November 1, 2021. Requirements in all other categories must be completed by December 1, 2021. Cities and agencies that have reached recognizable tiers by the stated deadlines will receive their awards at the Energy Work Group meeting on December 8, 2021.

Recently, the Cities of Irwindale and San Gabriel became the first two San Gabriel Valley jurisdictions to achieve the Silver recognition tier. Additionally, Foothill Transit and the Cities of Duarte, Monrovia, Montebello, Pomona, and San Dimas are each only one action away from the Silver category recognitions. Cities and agencies are encouraged to meet with SGVCOG staff regarding energy champion award progress. RE: SOCALREN KITS FOR KIDS PROGRAM

RECOMMENDED ACTION

BACKGROUND

The Southern California Regional Energy Network (SoCalREN) Kits for Kids Program introduces 4th-grade students from participating schools to energy efficiency. Each student receives a free kit, containing an interactive scavenger hunt and energy-efficient items to install in their homes. Enrolled classrooms are eligible to receive a \$1,000 grant if 65% of students install the energy-efficient items and provide proof of installation.

Families are encouraged to work together to complete the activities and install the provided items. Once all the measures are installed, families complete an installation verification card for the students to return to their teachers. The teachers then complete an online form verifying the student's installation for their classroom. If 65% of students complete the activities and submit a verification card, then the classroom may receive a \$1,000 grant.

Each Kit contains:

- Two LED bulbs
- One efficient-flow showerhead
- Two faucet aerators
 - o One 1.5 GPM kitchen faucet aerator
 - One 1.0 GPM bath faucet aerator

Benefits of this program include energy-efficiency education, free energy-efficient items that reduce energy usage and cost, grant support for classrooms that meet participation goals, and a reduction of residential communities' contribution to climate change.

In order to participate, schools must belong to a school district that is enrolled in the SoCalREN Public Agency Program. School districts may enroll for free at https://socalren.org/agencies/register, and schools that are already enrolled in the SoCalREN network may complete this interest form https://socalren.org/about/kits-for-kids/interest to begin program enrollment.

BACKGROUND

The South Coast Air Quality Management District (AQMD) recently published a guide on using air quality sensors. The guide, titled "Community in Action: A Comprehensive Educational Toolkit on Air Quality Sensors," includes a guidebook on air quality sensors, training videos, installation guides, surveys, data analysis and visualization tools, and community reports.

The Toolkit was shaped through the collaborative effort of 14 different California communities over the past five years and the experience of deploying nearly 400 air quality sensors under a U.S. Environmental Protection Agency "Science To Achieve Results (STAR)" grant. These tools and resources will promote effective and successful use of sensors, which can lead to increased education and awareness about air quality issues and ways to reduce exposure and emissions.
