### **BACKGROUND**

Cities across the San Gabriel Valley are implementing programs that provide new multimodal transportation services; complement and connect to existing fixed-route transit services; or replace existing transportation services, like dial-a-ride, altogether. SGVCOG staff have identified several member cities that are implementing these innovative programs in order to highlight local transportation programs and help build up regional knowledge and best practices. The following cities will present at this month's Transportation Committee meeting:

- Monrovia | GoMonrovia Lyft Pass
- South El Monte | SGV Carshare
- Covina | Fric and Frac Circulator
- West Covina | Go West Covina Microtransit
- Monterey Park | MPK Transit Express

This report contains a brief overview of each program.

### **MONROVIA'S GOMONROVIA LYFT PASS**

The GoMonrovia Lyft Pass provides residents of Monrovia and Bradbury with \$6 fixed-fare Lyft rideshares within the Monrovia/Bradbury service area. The rider pays the first \$6 for the ride, and the City pays any remaining balance up to \$15. Riders can use the Pass Sunday – Monday from 7:00 am to 10:00 pm and Friday and Saturday from 7:00 am and 1:00 am. Besides the Lyft Pass, GoMonrovia also includes "Monrovia Transit," the City's on-demand transit service for seniors and individuals living with disabilities.

The Lyft Pass program began in 2019 and was scaled up in 2023 when the City secured funding from LA Metro's Section 5310 Grant Program. With this funding, the city expanded the GoMonrovia Lyft Pass program to include same-day wheelchair accessible services, thereby bringing it into compliance with the Americans with Disabilities Act (ADA).

### **SOUTH EL MONTE'S SGV CARSHARE**

SGV Carshare provides San Gabriel Valley residents with the ability to borrow zero-emission vehicles (ZEVs) at a daily or weekly rate. Participants can reserve one of six vehicles stationed at the



South El Monte Civic Center parking lot by using an app provided by the program's vendor: Mobility Development Operations (MDO), LLC. All members must apply and pay a non-refundable \$20 application fee. Daily rentals (24 hours and 150 miles) are \$40 and weekly rentals (up to 7 days and 500 miles) are \$220. During their rental period, users can access 24/7 bilingual support.

Funding for this program comes from the California Air Resources Board's (CARB) Clean Mobility Options (CMO) Voucher Pilot program. The CMO program funds community-driven projects that improve access to clean transportation in under-resourced communities. The City received a total of \$1.5 million in funding to launch this program. Partners for this program include The Energy Coalition (TEC); MDO; and ActiveSGV. SGV Carshare will soon expand to service four new destinations in the City of El Monte, including the City's Metrolink Station, historic downtown, community center, and public works department.

### **COVINA'S FRIC & FRAC CIRCULATOR**

Free Rides In Covina and Free Rides Around Covina (FRIC & FRAC) provides free rides connecting downtown Covina destinations to the City's Metrolink station, several downtown parking structures, and various bus lines. This fixed-route circulator service utilizes three all-electric five-passenger vehicles that serve nine static stops located at key downtown interest points. FRIC & FRAC operates on Thursday and Sunday from 1:00 pm to 9:30 pm, and on Friday and Saturday from 2:00 pm to 11:00 pm.

The cost for the new vehicles was approximately \$115,000, with most funding provided through Department of Energy's Energy Efficiency and Conservation Block Grant (EECBG) program. The City authorized a \$300,000 contract with their dial-a-ride operator, Parking Co of America (PCAM), to operate FRIC & FRAC during the pilot period. Operational costs are covered by Proposition A funds and a lease agreement with Covina Kia for the use of city-owned parking facilities.

FRIC & FRAC functions both as a microtransit service and as a "placemaking" strategy for the City. The City's Economic Development division leverages the program as an amenity that can attract new visitors and foot traffic, with the goal of attracting additional investment in Covina's historic central business district. Staff highlight its unique and whimsical branding as a key part of this "placemaking" strategy. City staff also anticipate that FRIC & FRAC can serve the residents of the 600+ additional transit-oriented housing units planned for downtown Covina.

## WEST COVINA'S GO WEST COVINA MICROTRANSIT

Go West Covina provides riders with on-demand door-to-door trips throughout the northern West Covina service area and connects to the Metrolink stations in the neighboring cities of Baldwin Park and Covina. Riders can book rides between 7:00 AM and 7:00 PM, Monday through Friday, either by contacting a call center or by using a dedicated mobile app. Riders with disabilities can also reserve a wheelchair accessible vehicle (WAV) for their trip. During the one-year pilot which began in November 2024, all Go West Covina rides have been free of charge. The City contracts with Via Transportation, Inc. (Via) to implement the service.

This program is funded through LA Metro's Measure M "Visionary Seed Fund" (VSF), which competitively allocates funding to develop "innovative mobility concepts." The one-year contract with Via is for an amount not to exceed \$1,098,484. The City discontinued its Red and Blue line fixed-route shuttles beginning January 2025 in conjunction with Go West Covina implementation.



In October 2024, West Covina City Council authorized a one-year extension of the program through November 2026. This extension maintains the current service area, service model, and fare-free operations. City staff note that the pilot program has been a success. Between the program launch and August 2025, Go West Covina provided 19,123 rides with an average customer ride rating of 4.9 stars. Staff also note that the microtransit program has proven to be less expensive to operate than the discontinued fixed-route shuttles.

### MONTEREY PARK'S MPK TRANSIT EXPRESS

MPK Transit Express provides riders with on-demand door-to-door trips throughout Monterey Park and beyond to key destinations in neighboring jurisdictions. Riders can book rides between 6:30 AM and 7:30 PM, Monday through Friday, either by contacting a call center or by using a dedicated mobile app. Riders with disabilities can also reserve a wheelchair accessible vehicle (WAV) for their trip. MPK Transit Express rides are a flat \$2 fare, or \$1 for seniors (55+) and riders with disabilities. The City contracts with Via Transportation, Inc. (Via) to implement the service.

In mid-2024, the City completed an evaluation of its existing fixed-route local transportation, Spirit Bus. This analysis revealed declining ridership and rising operational costs, along with resident demand for more flexible transportation options. As a result of this study, the City Council approved a one-year pilot for the MPK Transit Express and approved route restructuring of its fixed route services.

MPK Transit Express launched in April 2025. Initially, it operated exclusively within the City limits and began at 7:30 AM. In August 2025, the City expanded the service to begin at 6:30 AM and offer rides to key destinations outside the city: Cal State Los Angeles, Atlantic/Pomona Metro E Line Station, and the Rosemead Walmart, to name a few. From April through July 2025, riders booked more than 2,700 rides through MPK Transit Express, 98% of which were booked through the app.
