RE: LEGISLATIVE POSITION – AB 1024 (HARABEDIAN)

RECOMMENDED ACTION

Recommend the Governing Board adopt a resolution in support of AB 1024 (Harabedian).

SUMMARY

AB 1024 directs the California Department of Fish and Wildlife (CDFW) to proactively manage and reduce human-bear conflicts in the San Gabriel Valley through a science-based regional planning effort. The bill mandates the creation of a localized bear management plan, the implementation of modern tracking systems, and the establishment of performance goals to reduce future bear encounters in residential areas.

Key Provisions:

- 1. <u>Regional Bear Management Plan</u>: Requires CDFW to develop and publish a comprehensive plan by January 1, 2027, addressing bear-related issues specific to cities in the San Gabriel Valley.
- 2. Plan Requirements: The plan must include:
 - o A behavioral overview of bears in the San Gabriel Mountains.
 - o Analysis of underlying factors leading to bear incursions into urban neighborhoods.
 - o Review of city-level ordinances and policies for managing urban bear interactions.
 - o Recommended best practices for municipalities to adopt.
 - A reassessment of CDFW's bear classification system to better align with local response protocols.
- 3. <u>Performance Metrics and Legislative Reporting</u>: Directs CDFW to establish quantifiable goals for reducing bear encounters and submit a report to the Legislature with these goals by January 1, 2027.
- 4. <u>Bear Tagging and Tracking</u>: Requires CDFW to tag and continuously monitor any bear that enters a residential neighborhood in the San Gabriel Valley using advanced technologies, such as GPS collars or AI-based tracking systems.

STATUS

AB 1024 passed the Assembly Water, Parks, and Wildlife Committee unanimously. It has subsequently been referred to the Appropriations Committee where it has been placed on the Suspense File.

AUTHORS STATEMENT



According to the author, "[This bill] is about protecting both our communities and the wildlife that call the San Gabriel Valley home. As bear encounters become more frequent, we must act with care and foresight to ensure the safety of our families while respecting the natural habitat of these animals. This bill establishes a thoughtful and proactive approach—one that prioritizes understanding bear behavior, reducing conflicts in residential areas, and using innovative technology to monitor and manage interactions. By planning ahead and implementing smart, humane solutions, we can create a safer, more harmonious coexistence between people and wildlife."

RECOMMENDED ACTION

Recommend the Governing Board adopt a resolution in support of S.1323 (Schiff).

SUMMARY

S.1323 – The Facilitating Increased Resilience, Environmental Weatherization and Lowered Liability (FIREWALL) Act – amends the Internal Revenue Code of 1986 to provide a refundable tax credit for disaster mitigation expenditures, outlined below:

- 1. <u>Disaster Mitigation Expenditures Tax Credit</u>: The proposed legislation introduces a refundable tax credit for individuals who make qualified disaster mitigation expenditures. The credit is set at 50% of qualifying expenditures with a maximum limit of \$25,000.
 - Credit phases out for taxpayers with an adjusted gross income over \$200,000.
 - Joint occupancy rules limit total expenditures to \$25,000 for shared dwelling units.
- 2. <u>Definitions of Qualified Expenditures</u>: The legislation outlines specific types of expenditures that qualify for the tax credit, focusing on improvements that enhance disaster resilience. These include structural reinforcements and the installation of protective systems. Specifics include:
 - Improvements to roofs, walls, and foundations,
 - Installation of flood prevention systems and fire-resistant materials, and
 - Services for vegetation management and risk assessment.
- 3. <u>Criteria for Qualified Dwelling Units</u>: The bill specifies the criteria for a dwelling unit to be considered qualified for the tax credit. This includes location and usage as a principal residence.
 - Qualified dwelling units must be in areas with recent federal disaster declarations per the Stafford Act.
 - Must be the principal residence of the taxpayer.
 - Areas must have received hazard mitigation assistance or be designated as community disaster resilience zones per the Stafford Act.
- 4. <u>Documentation and Compliance Requirements</u>: Taxpayers claiming the credit must provide adequate documentation of their expenditures. The legislation also prevents double benefits for the same expenditures.



5. Effective Date of the Legislation: The amendments proposed in the legislation would take effect for taxable years beginning after December 31, 2024. The new tax credit provisions would apply starting in the 2025 tax year.

STATUS

The Bipartisan bill was introduced on April 8, 2025, by Democratic Senator Adam Schiff alongside Republican Senator Tim Sheehy of Montana. The bill currently does not have additional cosponsors or a House companion bill. It has been referred to the Committee on Finance for further consideration.

AUTHORS STATEMENT

According to the Senator Schiff, "Helping families make their homes more resilient to natural disasters will help reduce the level of damage inflicted by future disasters and save American taxpayers in the long run. As California works to recover from the costliest natural disaster in its history, I'm proud that my first bill introduced in the Senate will help California communities and those in other disaster-prone states make the necessary upgrades that we know can reduce damage, prevent further devastation, and save lives."

SUPPORT AND OPPOSITION

S.1323 is currently endorsed by the International Association of Fire Fighters, National Association of Realtors, the National Association of Counties, Western Fire Chiefs Association, California Fire Chiefs Association, Alliance for Wildfire Resilience, Association of Firetech Innovation, Megafire Action, Fire Aside, PG&E, National Association of Realtors, Safe Community Project MySafe:LA Division, American Institute of Architects, Glendale Fire Department, International Alliance of Theatrical Stage Employees (IATSE) and Marin Wildfire Prevention Authority.

RECOMMENDED POSITION

Staff recommend the EENR Committee recommend the Governing Board adopt a resolution in support of S. 1323 (Schiff). This position aligns with the SGVCOG 2025-26 Legislative Priorities relating to wildfire preparedness, specifically, "SGVCOG supports the reduction of wildfire risk, promotion of wildfire prevention planning, and identification of funding for wildfire programs in the San Gabriel Valley."

EATON FIRE UPDATE

RECOMMENDED ACTION

For information only.

BACKGROUND

The San Gabriel Valley Mosquito and Vector Control District (SGVMVCD) is an independent special district with statutory authority and responsibility to protect public health from mosquito nuisance and mosquito-borne diseases. The SGVMVCD serves over 26 SGVCOG member cities, each of which appoints one representative to a governing Board of Trustees, ensuring that local accountability and oversight across a jurisdiction of more than 1.5 million residents is met.

EATON FIRE IMPACTS TO PUBLIC HEALTH

The Eaton Fire began on January 7, 2025, burning over 14,120 acres and destroying more than 9,000 structures. Post-fire assessments confirmed that about 2,811 unmaintained swimming pools in the impacted area, of which 1,408 are confirmed non-functional due to structural destruction, debris, or inaccessibility. Prior to the Eaton Fire, the SGVMVCD monitored 343 unmaintained swimming pools in the region.

Field monitoring shows that more than 80% of fire-damaged basins inspected are actively producing mosquito larvae. This percentage will continue to increase as seasonal temperatures rise, specifically, untreated basins that will continue to produce thousands of mosquitos weekly. The potential increase in mosquito breeding sites created by the Eaton Fire increases the risk of disease transmission in nearby communities. Such potential diseases include West Nile virus, dengue, and Saint Louis Encephalitis, all of which are transmitted by infected mosquitoes.

FUNDING IMPLICATIONS

The SGVMVCD is primarily funded through direct benefit assessment of local parcels, a model designed for routine operations and not scalable to disaster response. Emergency costs arising from disasters such as the Eaton Fire exceed the financial capacity of the SGVMVCD's funding framework. There is no federal or state agency involved in the cleanup effort that has the authority, training, or mandate to address vector control needs. As a result, the SGVMVCD is tasked with the costly responsibility of addressing this public health hazard.

Additional federal and state assistance is necessary for the SGVMVCD to address this critical



public health challenge. The SGVMVCD is pursuing funding through sources through the Federal Emergency Management Agency (FEMA) and state budget allocations.

(FRESH SGV) UPDATE

RECOMMENDED ACTION

BACKGROUND

The San Gabriel Valley Regional Food Recovery Program (FRESH SGV) was established to help member agencies comply with SB 1383's food recovery mandates and significantly reduce food waste in the San Gabriel Valley. Known as one of the largest regional food recovery programs in California, this program includes assessing commercial edible food waste generators, identifying and fostering partnerships with local food recovery organizations, implementing outreach and education endeavors, and developing and implementing inspection protocols. To support these efforts, the SGVCOG has issued three grant awards to develop regional "food hubs" that help recover and redistribute surplus edible food to people experiencing food insecurity. Currently, SGVCOG is overseeing inspections for businesses in participating San Gabriel Valley cities to ensure compliance with food waste reduction and donation requirements. These cities include:

INSTANT AC SAVINGS PROGRAM

Clean Power Alliance (CPA) residential customers on California Alternate Rates for Energy (CARE) or Family Electric Rate Assistance (FERA) rate assistance programs are eligible to receive a \$210 incentive towards the purchase of an energy efficient room air conditioner. Additionally, all CPA customers are eligible for a \$90 incentive provided by SCE. Together, these combined incentives provide \$300 in savings. See Attachment A for more information.

ENERGY ADVISOR SERVICE

The <u>Clean Power Alliance's Energy Team</u> is a program that helps customers with energy efficiency and electrification upgrades, offering personalized solutions and support. It provides free virtual energy assessments and customized plans to guide customers in making informed decisions about upgrades and accessing available rebates. SOUTH COAST AQMD CARL MOYER FUNDING

South Coast AQMD is currently accepting applications for the Carl Moyer Program, including the Surplus Off-Road Opt-In for NOx Provision (SOON). Approximately, \$48 Million in funding is available for 2025 to support projects within South Coast AQMD's jurisdiction.

Funding is available across several categories, including:

- On-road vehicles like transit buses, solid waste, public agency/utility vehicles, and emergency vehicles;
- Off-road vehicles such as construction equipment; and
- Infrastructure like electric chargers, alternative fuel stations for zero-emission and near zero-emission vehicles.

South Coast AQMD will offer resources during the application process to assist with program requirements, eligibility, and a tutorial for the online application portal. The online application deadline is July 1, 2025, at 1:00 p.m. PST. For more information, visit the Carl Moyer Program webpage at www.aqmd.gov/moyer.

VOLKSWAGEN (VW) MITIGATION TRUST

The Volkswagen (VW) Mitigation Trust Funds for Transit, School and Shuttle Bus has \$130 million in funds to replace older, high-polluting transit, school, and shuttle buses with new battery-electric or fuel-cell buses. Replacing an older bus with a zero-emission bus eliminates particulate matter and other pollutants that impact California communities.

Applications are currently being accepted for transit and shuttle buses. Applications are processed on a first-come, first-served basis and will be considered for funding if eligible and while project funds are available.

Maximum funding amounts:

- Transit Buses
 - o Up to \$216,000 for new, battery-electric transit buses
 - o Up to \$480,000 for new, fuel-cell transit buses
- Shuttle Buses
 - o Up to \$192,000 for new, battery-electric shuttle buses

COMMERCIAL ELECTRIC LAWN & GARDEN EQUIPMENT

The Electric Lawn & Garden (eL&G) Program reduces the purchase price of the commercial-grade battery electric lawn and garden equipment. Up to 85% discount will be provided, up to the funding caps listed below (whichever is less):

• Chainsaws/Trimmers/Edgers/Brush Cutters: Up to \$700

• Leaf blowers/Vacuums: Up to \$1400

• Walk Behind Lawn Mowers: Up to \$1500

• Ride-on or Stand/Sit Lawn Mowers: Up to \$15,000
