CITIZEN PARTICIPATION: Your participation is welcomed and invited at all Committee meetings. Time is reserved at each regular meeting for those who wish to address the Board. SGVCOG requests that persons addressing the Committee refrain from making personal, slanderous, profane, or disruptive remarks.

TO ADDRESS THE COMMITTEE: At a regular meeting, the public may comment on any matter within the jurisdiction of the SGVCOG during the public comment period at the beginning of the agenda, on any item(s) that is on the Consent Calendar prior to action taken on the Consent Calendar, and on any other agenda item prior to the time it is considered by the Committee. At a special meeting, the public may only comment on items that are on the agenda. Members of the public are requested to state their name prior to speaking, and comments are limited to a maximum of three minutes per person. The Committee Chair may impose additional time limits if comments become repetitious, an individual member of the public seeks to speak on numerous items, or a large number of members of the public seek to speak on an item. The Committee may not take action on items not on the agenda and is restricted in discussing items on the agenda.

MEETING MODIFICATIONS DUE TO THE STATE AND LOCAL STATE OF EMERGENCY RESULTING FROM THE THREAT OF COVID-19: AB 361 (Rivas), signed by California Governor Gavin Newsom on September 16, 2021, authorizes local agencies to hold public meetings via teleconferencing and allows for members of the public to observe and address the meeting telephonically or electronically to promote social distancing due to the state and local emergency resulting from the threat of the Novel Coronavirus (COVID-19).

To follow the new provisions in AB 361 and ensure the safety of Committee Members and staff for the purpose of limiting the risk of COVID-19, in-person public participation at the Homelessness Committee meeting will not be allowed. ENABLE THE HOMELESSNESS COMMITTEE TO CONTINUE TO

HOLD MEETINGS VIA TELECONFERENCING

RECOMMENDED ACTION

Adopt Resolution 22-15-HC making specified findings that the existence of a local and state of emergency in California caused by the ongoing COVID-19 pandemic continues to directly impact the ability of the SGVCOG to hold public meetings safely in person thereby necessitating an ability to continue holding meetings via teleconferencing.

BACKGROUND

Introduced by Assemblymember Robert Rivas (D-Hollister) on February 1, 2021, AB 361 codifies portions of Governor Gavin Newsom's existing Ralph M. Brown Act exemptions pertaining to teleconferencing if a local agency issues an emergency finding, and reissues it every 30 days, that it is unsafe to meet in person. Specifically, the Brown Act exemptions include requirements to provide a public teleconference location, to maintain a member quorum within the agency's jurisdiction and to provide for public comment at each teleconference location, such as a private residence. The legislation expires in December 2024. On September 16, 2021, California Governor Gavin Newsom signed AB 361 into law, effective immediately.

A local agency wishing to rely on the provisions of AB 361 must meet one of the following criteria:

- 1. The local agency holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- 2. The local holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- 3. The local agency holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California due to the threat of COVID-19 and shortly thereafter issued Executive Order N-29-20 suspending certain Brown Act provisions relating to teleconferencing as public meetings began to be held online. However, this Executive Order expired on September 30, 2021, despite the State of Emergency remaining in place.

¹ Similarly, on March 4, 2020, the Los Angeles County Board of Supervisors and Los Angeles County Health Officer declared a local and health emergency due to the threat of COVID-19.



The threat that COVID-19 has presented continues to directly impact the ability of the SGVCOG to conduct Governing Board/committee meetings safely in person. Updated guidelines issued by the Centers for Disease Control and Los Angeles Department of Public Health in July and August 2021 advise governmental entities to refrain from conducting indoor meetings and consider moving operations outdoors, where feasible, to prevent transmission. SGVCOG staff finds it has been unable to find a suitable outdoor space with the requisite audio/visual capabilities at which the monthly Committee meetings can be held safely. Similarly, an indoor space with sufficient capacity to accommodate safe social distance practices among members, staff, and the public could not be identified

In order to continue to conduct meetings in a safe manner and to prevent unnecessary COVID-19 exposure to members, staff and the public, staff is recommending that the Homelessness Committee adopt a resolution making certain findings in order to be able to continue teleconferencing for its meetings.

RE: 2023 LEGISLATIVE PRIORITIES

RECOMMENDED ACTION

Recommend Governing Board adopt 2023 Legislative Priorities related to homelessness.

BACKGROUND

The SGVCOG Governing Board annually adopts a comprehensive legislative platform consistent with the Strategic Plan furthers the interests of the region and our member agencies. The platform helps guide and inform the legislative, policy, and programmatic actions and positions taken by the SGVCOG over the course of the calendar year. This report reviews the accomplishments in the area of homelessness policy in 2022 and presents proposed objectives for 2023.

The proposed legislative priorities build upon those adopted in previous years. The only notable change was to add a specific reference to the BRCH recommendations as it relates to LAHSA reform.

Accomplishments

State:

- Supported AB 2233 (C. Garcia & Quirk-Silva), which was signed into law and will require the Department of General Services (DGS) to develop a plan to facilitate development of affordable housing on state-owned excess land.
- Supported SB 914 (Rubio), which was signed into law and will enact the Homeless Equity for Left Behind Populations (HELP) Act, requiring cities, counties, and continuums of care that receive state funding to take specific actions to address the needs of domestic violence survivors and unaccompanied women, as specified; and, requires the Interagency Council on Homelessness (Cal ICH) to establish initial goals to prevent and end homelessness among domestic violence survivors, their children and unaccompanied women, as provided, and to evaluate the goals at least every two years to determine whether updates are needed.
- Supported SB 1338 (Umberg & Eggman), which was signed into law and will establish the Community Assistance, Recovery, and Empowerment (CARE) Act to provide comprehensive treatment, housing, and support services to Californians with complex behavioral health care needs.
- Successfully secured \$850,000 in additional state funds from State Senator Portantino for the SGV Crisis Assistance and Response Engagement Program (SGV CARE).



Local:

- Supported Homelessness Committee Chair Becky Shevlin in her role as an appointee to the Blue Ribbon Commission on Homelessness (BRCH) and provided comments to the BRCH and to the Los Angeles County Board of Supervisors (LACBOS) in support of BRCH recommendations that would best support people experiencing homelessness (PEH) in the San Gabriel Valley.
- Advocated for increased funding for cities and councils of governments (COGs), resulting in the establishment of \$10 million "Local Solutions Fund" that will provide additional financial resources for COGs and cities.
- Advocated to the LACBOS for more funding to support mental health and health Services for PEH.
- Partnered with the SGVRHT and the City of Baldwin Park on a successful application for one year of operational funding through the County's Cities and Councils of Government Interim Housing Solutions Fund for the City of Baldwin Park's Esperanza Villa 25-unit tiny home interim housing village.
- Closed-out the expenditure of \$5.625 million in funding received through a State Budget Earmark. This Budget Earmark provided funding to 24 cities to support the implementation of each city's homelessness plans and funding to 24 cities to implement prevention and diversion programs targeted at preventing people from falling into homelessness in the first place.
- Contracted with Los Angeles Centers for Alcohol and Drug Abuse (LA CADA) to launch the "Services to Supplement Existing Services" and "High Acuity and Substance Use Disorder-Focused Services" programs for 17 San Gabriel Valley cities. The "Services to Supplement Existing Services" Program provides 3 4-person multidisciplinary teams to provide services and house PEH in 3 cohorts of San Gabriel Valley cities, and the "High Acuity and Substance Use Disorder-Focused Services" programs provides 2 2-person teams focused on providing services and housing to those clients that need the most support in being housed. These Programs are funded through the \$3.525 million in Measure H Funding that the LACBOS allocated to the SGVCOG for the period from January 2022 June 2023.
- Launched the SGV CARE Program, which will provide alternative mobile crisis response to local law enforcement. The Program provides 2 2-person teams including a mental health clinician and an emergency medical technician (EMT) that can respond to non-violent 911 calls, such as those experiencing a mental health crisis, include those who are unhoused.
- Selected by the Harvard Kennedy School (HKS) Government Performance Lab (GPL) to receive pro-bono technical assistance for one year to support the launch and implementation of the SGV CARE Program. The SGVCOG was one of four governments nation-wide selected to serve as part of their cohort of governments launching mobile crisis programs. The other four governments selected were the cities of Chicago; Washington, DC; and Allegheny County, PA (Pittsburgh, PA area).
- Partnered with the City of Baldwin Park and the SGVRHT to construct and operate a 16unit tiny home village called "Serenity Homes" to provide temporary housing for families



- experiencing homelessness in Baldwin Park. The project is the first tiny home site for families in California.
- Partnered with the City of Montebello and the SGVRHT to construct and operate a 30unit tiny home village called "Operation Stay Safe" to provide temporary housing for individuals experiencing homelessness in Montebello.
- Successfully advocated for SB 1177, establishing the Burbank-Glendale-Pasadena Regional Housing Trust Fund.
- Launched the Food Insecurity Program, which will assist cities, nonprofits, and service providers in establishing and/or increasing their capacity to collect food and distribute food to people experiencing homelessness or those at-risk of homelessness.
- Launched the Housing Linkage Working Group for cities to pilot innovative approaches and activities to connect people experiencing homelessness with permanent housing.

2023 HOMELESSNESS LEGISLATIVE PRIORITIES

Based on these accomplishments and developments, staff recommend adoption of the following legislative priorities for calendar year 2023. Many of these recommendations are identical to those that were approved in 2022.

State and Federal:

- Support legislation that promotes solutions to homelessness for those facing mental health and/or substance abuse challenges.
- Support funding for programs that provide additional resources for homeless persons facing mental health and/or substance abuse challenges.
- Support funding, particularly direct, non- discretionary funding, for the SGVRHT and other entities that will create affordable housing for the region.
- Support funding for the creation of housing units especially very low, low, and moderate income while respecting cities' local control of land use decisions.
- Support legislation and funding for programs that encourage workforce development activities for persons experiencing homelessness.
- Support funding for thoughtful programs aimed at preventing people from falling into homelessness, including innovative local programs instituted by local cities.
- Support legislation and funding for projects and programs that address quality of life issues, including public safety and water quality for all residents, including homeless persons.
- Support funding for homelessness programs administered by COG and its member agencies.
- Advocate for regional approaches that allow cities to comply with their Regional Housing Needs Assessment (RHNA) requirements.
- Support for financial incentives and tax advantages (such as the waiver of property value reassessments) for the construction of accessory dwelling units, particularly when they are restricted to house low-income individuals.



- Advocate for funding for permanent supportive housing (PSH) resources dedicated to those with mental illness, including through project-based housing, tenant based rental assistance, and Los Angeles County's "restorative care village" model.
- Support efforts to better meet the needs of those who require a higher level of care than PSH, including by increasing the State payment rate for licensed board and care homes, as well as one-time funding necessary to prevent the closure of such facilities.
- Advocate for the direct allocation of State funding, including but not limited to the Homeless Housing Assistance and Prevention (HHAP) Program, to sub-regional entities in addition to continuums of care (CoCs) and jurisdictions greater than 300,000 people.

Local:

- Promote the allocation of Measure H resources towards cities' projects and programs as well as regional projects and programs that work to solve the homelessness crisis in the San Gabriel Valley.
- Support funding for prevention programs that stop the flow of residents into homelessness, including innovative local programs instituted by local cities.
- Promote collaboration between the County of Los Angeles and the San Gabriel Valley cities in implementing projects, policies, and programs that work to solve the homelessness crisis in the San Gabriel Valley.
- Support reforms to the structure and function of the Los Angeles Homeless Services Authority (LAHSA) and/or elements of the County homeless services system including BRCH recommendations, to better meet the needs of the San Gabriel Valley.
- Support efforts, funding, and partnerships with the Los Angeles County Department of Mental Health (DMH) to implement locally-based alternative crisis response models, particularly as relates to non-violent crises by people experiencing homelessness.
- Support enhanced data gathering and sharing to advance understanding of and response to homelessness among all regional public and non-profit agencies to supplement the annual Point-in-Time count.
- Recommend the County of Los Angeles Board of Supervisors and other public entities, such as the State, community college districts, and school districts evaluate the use of surplus or underutilized public facilities for mental health treatment and housing for mental illness.
- Advocate for funding for homelessness programs, and the construction and operation of interim and permanent housing units in the San Gabriel Valley.

Staff recommends the adoption of these legislative priorities intended to advance the SGVCOG's homelessness goals and initiatives. These priorities will be presented to the Governing Board for consideration at their January 2023 meeting.

RE: THE INN BETWEEN

RECOMMENDED ACTION

BACKGROUND

According to a report released by the Los Angeles County Department of Public Health, there were 1,776 deaths for people experiencing homelessness in 2020¹. Many of the illnesses and conditions that people face can be much worse for the homeless, who often lack access to medical care and permanent housing. As people experiencing homelessness age, the toll of living and sleeping outdoors becomes increasingly challenging to manage.

The INN Between, a nonprofit organization located in Salt Lake City, Utah, opened on August 17, 2015, as a 16-bed pilot project. The INN Between's mission is to end the tragedy of vulnerable people dying on the streets by providing medical respite and end-of-life care to those experiencing homelessness. Due to the growing demand, the organization expanded and moved to a larger facility in 2018. The INN Between is licensed and zoned for 50-beds, which include the following:

- 25 Assisted Living Facility Type II beds—for adults who need assistance performing their activities of daily living, which include bathing, grooming, dressing, eating, toileting, and taking medication.
- 25 Eleemosynary Facility beds-for adults who are capable of performing their own activities of daily living.

The organization adheres to the hospice philosophy of providing care for the sick, especially the terminally ill, and treating the whole person by providing support for his or her emotional, social, and spiritual needs in addition to the medical symptoms. Clients are referred to the INN Between from hospitals, medical clinics, Volunteers of America, the Salt Lake City Police Department, Unified Police Department, The Road Home, churches, and other homeless service agencies. No one is turned away for inability to pay.

At the INN Between, clients receive the following:

- all basic needs;
- transportation to medical appointments;
- intensive case management to connect with mainstream benefits such as Medicaid and Disability Income;
- substance use recovery support with daily transportation to Methadone clinics;

• activities to promote wellness, positive interaction with others and the community, and self-sufficiency.

The INN Between is not a hospice provider but rather a temporary housing solution that gives homeless individuals access to professional hospice care, since hospice care is a home-based medical service that cannot be delivered on the streets or in shelters. All hospice care at the INN Between is provided by licensed agencies. In general, hospice care includes home nurse and doctor visits, medications to control pain and anxiety, home medical equipment, and comprehensive emotional, social, and spiritual support. On average, one-third of residents are struggling with a terminal illness. The INN Between also provides medical respite, a stabilization service that provides short-term stays to individuals who are too ill to be on the streets or in shelters but who are not ill enough to be in the hospital. During their stay, medical respite residents receive transportation to medical appointments and intensive case management to connect them with mainstream benefits, employment, and community-based housing. The INN Between also provides a limited number of long-term placement beds for individuals who are not suitable for community-based housing due to their medical acuity but lack the resources to afford traditional Assisted Living.
