TO ADDRESS THE GOVERNING BOARD: At a regular meeting, the public may comment on any matter within the jurisdiction of the SGVCOG during the public comment period at the beginning of the agenda, on any item(s) that is on the Consent Calendar prior to action taken on the Consent Calendar, and on any other agenda item prior to the time it is considered by the Board or Committee. At a special meeting, the public may only comment on items that are on the agenda. Members of the public are requested to state their name prior to speaking, and comments are limited to a maximum of three minutes per person. The Board President or Committee Chair may impose additional time limits if comments become repetitious, an individual member of the public seeks to speak on numerous items, or a large number of members of the public seek to speak on an item. The Board or Committee may not take action on items on the agenda and is restricted in discussing items on the agenda.

***MEETING MODIFICATIONS DUE TO THE STATE AND LOCAL EMERGENCY RESULTING FROM THE THREAT OF COVID-19:** AB 361 (Rivas), signed by California Governor Gavin Newsom on September 16, 2021, authorizes local agencies to hold public meetings via teleconferencing and allows for members of the public to observe and address the meeting telephonically or electronically to promote social distancing due to the state and local emergency resulting from the threat of the Novel Coronavirus (COVID-19).

To follow the new provisions in AB 361 and ensure the safety of Board Members and staff for the purpose of limiting the risk of COVID-19, in-person public participation at the Governing Board meeting will not be allowed. To allow for public participation, the Governing Board will conduct its meeting through Zoom Video Communications. RE: **ADOPT JOINT RESOLUTION 22-46 OF THE CAPITAL PROJECTS AND CONSTRUCTION COMMITTEE, ENERGY, ENVIRONMENT, AND NATURAL RESOURCES COMMITTEE, EXECUTIVE COMMITTEE, GOVERNING BOARD, HOMELESSNESS COMMITTEE, TRANSPORTATION COMMITTEE, AND WATER COMMITTEE MAKING FINDINGS TO ENABLE THEM TO CONTINUE TO HOLD MEETINGS VIA TELECONFERENCING**

RECOMMENDED ACTION

Adopt Joint Resolution 22-46 making certain findings that the existence of a local and state of emergency in California exists, that social distancing being mandated or recommended by state or local officials due to the ongoing COVID-19 pandemic and that meeting in person presents an imminent risk to the health and safety of attendees.

BACKGROUND

Introduced by Assemblymember Robert Rivas (D-Hollister) on February 1, 2021, AB 361 codifies portions of Governor Gavin Newsom's prior order suspending certain teleconferencing requirements under the Ralph M. Brown Act. It permits a local agency to continue to teleconference with fewer limitations if a local agency makes specified findings, and upon making such findings for the first time, makes the findings every 30 days thereafter. Specifically, the AB 361 exempts a local agency from Brown Act requirements to post agendas and make accessible to the public every location from which a member of a Brown Act body teleconferences. The legislation expires in December 2024. On September 16, 2021, California Governor Gavin Newsom signed AB 361 into law, effective immediately.

A local agency wishing to rely on the provisions of AB 361 must meet one of the following criteria:


1. The local agency holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
2. The local agency holds a meeting during a proclaimed state of emergency and has determined, by majority vote, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California due to the threat of COVID-19 and shortly thereafter issued Executive Order N-29-20 suspending certain Brown Act provisions relating to teleconferencing as public meetings began to be held online.¹ However, this Executive Order expired on September 30, 2021, despite the State of Emergency remaining in place.

The threat that COVID-19 has presented continues to directly impact the ability of the SGVCOG to conduct Governing Board/committee meetings safely in person. The Centers for Disease Control and Los Angeles Department of Public Health (LADPH) continue to advise governmental entities to refrain from conducting indoor meetings and consider moving operations outdoors, where feasible, to prevent transmission. Additionally, LADPH continues to recommend social distancing measures throughout Los Angeles County in all settings.

In order to continue to conduct meetings in a safe manner and to prevent unnecessary COVID-19 exposure to members, staff and the public, staff is recommending that the Capital Projects and Construction Committee, Energy, Environment, and Natural Resources Committee, Executive Committee, Governing Board, Homelessness Committee, Transportation Committee, and Water Committee adopt a resolution making certain findings in order to be able to continue teleconferencing for its meetings.

This resolution will be considered at a joint meeting of the Capital Projects and Construction Committee, Energy, Environment, and Natural Resources Committee, Executive Committee, Governing Board, Homelessness Committee, Transportation Committee, and Water Committee. For the purposes of this joint meeting, the Governing Board delegate or alternate representing each SGVCOG city will be the voting member for any other standing policy committee on which the city holds a seat. When roll call is taken and your name called, your vote will be counted toward both the Governing Board count and the Committee(s) upon which your city is a member. If you desire to register a different vote for the Board and the Committee upon which your city is a member, please indicate the vote for the Governing Board and for the Committee at the time your name is called. Otherwise, a single “yes” or “no” vote will be counted as a “yes” or “no” vote for both the Governing Board and the Committee(s) upon which your city sits. If a city’s Governing Board delegate and alternate are not present, the sitting delegate of a policy committee may be present for the purposes of roll call and may vote on agenda items concerning their committee. The Capital Projects and Construction Committee must have a quorum of their sitting members present and may not achieve a quorum by the attendance of their city’s Governing Board delegate or alternate alone.

RE: **RESOLUTION TO APPROVE SUBMITTAL OF REGIONAL CLIMATE COLLABORATIVES GRANT APPLICATION**

RECOMMENDED ACTION

Adopt Resolution 22-47 approving the submittal of an application to the Regional Climate Collaboratives Grant Program.

BACKGROUND

The California Strategic Growth Council released an application for the Regional Climate Collaboratives (RCC) program which encourages cross-sectoral partners to form collaboratives to address climate resiliency in under-resourced communities. Building upon the interim housing partnerships with the cities of Baldwin Park and Montebello, which include sustainable features such as greywater irrigation and recycled paint, SGVCOG and SGVRHT staff drafted a sustainable housing program outline. Staff met with staff from the RCC program to confirm program eligibility. Through the Affordable Housing Incubator, the SGVRHT has secured consultant support from Harris and Associates to assist with the RCC program application.

DISCUSSION

Staff proposes that the SGVCOG submits an application to develop an affordable housing sustainability program to support the development of innovative housing. Initial partners would include the Cities of Baldwin Park and Montebello as well as workforce development partners. Eligible costs include staff costs, administrative costs, and engagement and community outreach expenses including materials, stipends, and refreshments. The grant would provide capacity building support to develop a sustainable housing program in collaboration with the SGVRHT and develop a pilot program to deliver sustainable housing units in the San Gabriel Valley.

The Strategic Growth Council requires the grant applicant's Governing Body to certify by resolution the approval of the application before submission, therefore staff recommends the Governing Board to adopt Resolution 22-47 approving the submittal of an application to the California Strategic Growth Council Regional Climate Collaboratives (RCC) Grant Program and authorize the Executive Director to accept the funds if awarded. If approved, staff will ensure the RCC Grant application is submitted prior to the October 7, 2022 deadline. Awards are anticipated to range from \$500,000 to \$1,750,000 and award recommendations will be made in December.

RE: **HOUSING LINKAGE WORKING GROUP**

RECOMMENDED ACTION

Allocate \$200,000 to implement activities that would increase access to permanent housing options for persons experiencing homelessness (PEH), through the creation of a Housing Linkage Working Group.

BACKGROUND

Over the last several years, there have been growing resources allocated to providing services for persons experiencing homelessness (PEH) and to developing interim housing options. For example, the SGVCOG has contracted with the Los Angeles Centers for Alcohol and Drug Abuse (LA CADA) to provide multi-disciplinary outreach teams to serve nineteen cities and to provide targeted engagement to those PEH who need the greatest support in being housed to serve eight cities. Several other cities have also contracted with LA CADA or other service providers to provide additional services. In addition, the SGVCOG and the San Gabriel Valley Regional Housing Trust (SGVRHT) have partnered with the cities of Baldwin Park and Montebello to open two interim housing sites – Esperanza Villa in Baldwin Park and Operation Stay Safe in Montebello – that collectively provide 55 units of bridge housing. An additional family transitional housing site that will provide 16 units and approximately 50 beds for families – called Serenity Homes – will open in Baldwin Park in September.

While these services and interim housing options are critical components of the homeless services system, a key component of the system is the availability of permanent housing. Permanent supportive housing (PSH) and affordable housing that is protected by an affordable housing covenant are the most reliable options for providing housing for PEH. However, they are also extremely expensive to build and have long timelines for construction. As a result, there is not an adequate supply of PSH and affordable housing.

With the shortage of PSH and affordable housing, the system predominantly relies on clients finding “affordable” housing on the private market and renting those units using a housing subsidy. Housing subsidies include permanent housing subsidies – like Section 8 Housing Choice Vouchers¹ and Emergency Housing Vouchers (EHVs)²– and the time limited subsidy program overseen by the Los Angeles Homeless Services Authority (LAHSA). The time limited subsidy (TLS) program provides short-term funding for clients while they stabilize their income enough to

¹ Housing Choice Vouchers are matched to clients, and, upon receipt, the client can use the housing choice voucher to rent any unit on the private market that accepts vouchers and that does not exceed the maximum rent.

² EHV's function like Housing Choice Vouchers; however, they were additional vouchers allocated to public housing authorities nationwide as part of the American Recovery Plan.

afford the unit without any voucher or support. While these resources are also extremely limited and many clients in need are not matched with a voucher or TLS, these housing subsidy programs remain a key pathway out of homelessness for many clients.

However, using these vouchers can be extremely challenging. Clients must find a unit that does not exceed the maximum allowable rate of the voucher to rent on the private market. In addition to the typical challenges of finding an affordable apartment on the rental market, these clients face many additional challenges: the market rent in many communities greatly exceeds the maximum allowable rate of the voucher; some clients have little experience in searching for apartments; some clients don't have the credit scores, required documents and paperwork, or an ID to make them eligible for a unit. In addition, landlords that accept housing vouchers may be subject to additional inspections. The lack of permanent housing exits has a large impact on the operation of interim housing projects. When a client in an interim housing site is unable to move from interim housing to permanent housing, this means this space does not open for currently unsheltered clients. The County Homeless Initiative has placed a large focus on identifying and implementing approaches towards increasing the availability of permanent housing, which directly impacts the SGVRHT funded sites that received operational funding through the Cities and COGs and Interim Housing Services (CCOGIHS) fund. The CCOGIHS grant does not include funding for permanent housing identification, further demonstrating the need for additional local funding.

There are several resources designed to help clients move into housing. For example, LAHSA oversees the housing navigation program, which provides staff resources to help clients to fill-out paperwork and secure the required documents to get into housing. A recent policy change at LAHSA redirected all housing navigation resources in the County exclusively to clients currently in interim housing. However, the housing navigation is still not sufficiently-resourced to properly serve all of these clients. In addition, this means that any client that is currently unsheltered would not have access to the housing navigation program and must instead rely on other resources within the homeless services system or have no support at all.

There are also many programs that provide financial incentives and protections for landlords that lease to tenants that are paying with a housing voucher. While in California, it is illegal for a landlord to not lease to a tenant based on their source of income, the reality is that renting to a tenant with a housing voucher does take additional time – as additional inspections and paperwork is required – and it will take more time for the landlord to begin receiving rent. These landlord incentive programs are designed to make it more attractive for landlords to accept these clients. For example, the Countywide LeaseUp program provides holding fees, vacancy loss funds, wrap-around support for all participating properties and landlords. The County's Homeless Incentive Program (HIP) provides one month's free rent, move-in assistance, damage mitigation, and vacancy loss payments. The SGVCOG operated its Landlord Incentive Program – operated by Union Station Homeless Services (USHS) – that provided similar incentives for landlords. Several housing authorities offered signing bonuses for landlords that accepted EHVs. While all of these programs are important, they have not had as broad of an impact as expected in increasing the number of units available to clients with vouchers on the private market.

DISCUSSION

Given the need for affordable, permanent housing options on the private market, there is clearly a need to use innovative approaches to increase the supply of immediately-available housing. There are innovative approaches to try – for example, some cities are extremely proactive about engaging landlords in their community; others have tried to identify potential units for shared housing. However, there is not sufficient funding to truly implement many of these innovative ideas.

Due to cities and service providers' challenges in expending previous funds, the SGVCOG currently has approximately \$550,000 in unallocated funds which can be used for activities that support PEH or those at-risk of homelessness. At its August meeting, the SGVCOG Governing Board allocated \$250,000 of these funds towards the implementation of a food insecurity grant program.

Staff is proposing that \$200,000 of the remaining funds be allocated to create a grant program that would pilot innovative approaches and activities to connect PEH with permanent housing. The purpose of the Program would be to test potential approaches at a small scale and evaluate their impact in connecting clients to permanent housing.

Cities would be eligible applicants for this grant program. While a city would be required to be the main applicant, a city could apply in coordination with a service provider or other partner. Eligible activities would include any activities necessary to implement proposed programs, which could include but is not limited to staff time and relationships with service providers. Potential project ideas could include housing navigation, targeted engagement of landlords, shared housing programs, roommate matching programs, and the establishment of small-scale master leasing/resident and property support services (RPSS). While staff is not recommending a maximum funding award for a grantee, SGVCOG hopes to fund three to four cities under the grant. Projects would be evaluated predominantly based on their potential to ease improve clients' connections to permanent housing.

It is anticipated that some of the programs would include landlord incentives or other direct client services that would help incentivize participation or reduce barriers for clients. As such, a portion of the funds would also be held "incentive dollars," and all grantees could access these as part of their program implementation. Incentive dollars could fund things like landlord incentives (e.g. signing bonuses, deposits, incentives to hold a unit) and direct client services (e.g. application fees, credit repair/debt relief programs, etc.).


A key component of the program would be to build a cohort of implementers, to create a space for grantees to discuss challenges and opportunities, troubleshoot issues, and discuss best practices. All grantees would be required to participate in the "Housing Linkages Working Group," which would meet regularly and provide a forum within which participating cities could communicate on a regular basis. SGVCOG staff would also share best practices and provide whatever support necessary for participating entities.

The ultimate goal of the grant program would be to evaluate the impact of programs and their potential for regional scaling or duplication in other cities. Grantees would be asked to, in coordination with the SGVCOG, establish data metrics, and to collect project data. The SGVCOG

would also work with grantees to develop case studies, fact sheets, and how-to guides on the programs. At the end of the Program, SGVCOG staff would present the evaluation of the programs. Ultimately, the SGVCOG hopes to identify a menu of alternatives that could be implemented to help better facilitate connections to permanent housing.

NEXT STEPS

At its September 7, 2022, meeting, the Homelessness Committee approved a motion to recommend Governing Board allocate \$200,000 to implement activities that would increase access to permanent housing options for persons experiencing homelessness (PEH), through the creation of a Housing Linkage Working Group. Should this action be approved by the Governing Board, staff will release a simple application for cities to submit.

RE: **SGVCOG RULES OF DECORUM FOR PUBLIC MEETINGS**


RECOMMENDED ACTION

Adopt Resolution 22-48 to approve SGVCOG rules of decorum for public meetings.

BACKGROUND

In order to provide a safe and mutually respectful environment for the SGVCOG to conduct public meetings, staff is recommending adopting rules of decorum to be upheld for all SGVCOG public meetings. These rules of decorum will ensure that all members of the public, SGVCOG Board Members and SGVCOG employees are free from harassment, disruptions, and intimidation. Additionally, the proposed rules of decorum incorporate provisions of a recent bill signed into law, SB 1100, that addresses disruptions at public local government meetings. Authored by Senator Dave Cortese, SB 1100 outlines a new process in which the presiding member of a legislative body conducting a meeting, or their designee, may remove an individual for disrupting a public meeting. Attachment A contains the full proposed rules of decorum for SGVCOG public meetings that are being presented for Governing Board adoption.

DISCUSSION


Serenity Homes is a family bridge housing site opening later this month in the City of Baldwin Park. It is the first family tiny home bridge housing site in the State and will be operated by City Net, a supportive service provider. Families will work with the case manager to increase income and benefits enrollment and establish connections to permanent housing.

The virtual tour will provide a preview of the site which includes 16 Boss Cubez units (144 square feet), onsite laundry and restroom facilities, a computer room, and a case management office. The asphalt paint at the site will serve to reduce the heat impact of the pavement, provide color, and will include games such as four square and hopscotch. The paint is recycled by a local vendor, Montage, and brings a new sustainability component to this project.

The City received a \$1.2 million dollar grant from the SGVRHT to develop the site and operational funding was secured from the Los Angeles Homeless Services Authority (LAHSA) and the City. This represents the first LAHSA contract executed directly with a City. The site was developed by the City's Public Works team in collaboration with volunteer labor from Habitat for Humanity and Brother's Keeper Carpenter's Training Fund. The grand opening is scheduled for September 24th at 11AM and is open to the public; the invitation flyer is attached.

RE: **PURE WATER CALIFORNIA UPDATE ON RECYCLED WATER PROGRAM**

RECOMMENDED ACTION

BACKGROUND

The Pure Water Southern California Program is a partnership between the Metropolitan Water District of Southern California and the Los Angeles County Sanitation Districts. The program aims to create a new water supply to help meet the region's needs by providing up to 150 million gallons of water daily or 168,000 acre-feet-year, enough for 500,000 homes. The water could also replenish groundwater basins, be used by industries, and potentially be integrated into Metropolitan's existing drinking water treatment and delivery system.

The program would purify water used by homes, businesses and industries to create a reliable supply. Currently, this water flows to the ocean instead of being captured and recycled. The program would implement an advanced purification process, resulting in high quality water that is routinely monitored and tested. By diversifying the San Gabriel Valley's water supply sources, the program would help the region prepare for an earthquake or other emergency that could disrupt traditional supplies. The program is also a timely answer to dwindling groundwater stores. Groundwater basins in the region provide 30% of Southern California's water supply and have seen levels drop to historic lows in recent years. The program has the potential to help refill these basins. Lastly, the program will mitigate dependence on imported water supplies from the Colorado River and Sierra Nevada, allowing for more local autonomy.

There are additional economic benefits to water recycling. The construction costs and later the operation and maintenance costs will funnel new jobs and investment into the region. Pure Water Southern California estimates that the construction phase would generate \$3.46 billion in labor income, \$402 million in state and local taxes, and 47,100 jobs. The annual benefits derived from operation and maintenance are expected to include \$88 million in labor income, \$25.9 million in state and local taxes, and 1,040 jobs.
