

Each member or alternate shall have one vote. A quorum is 50% of its membership. Action taken by the Committee shall be by simple majority of the members present.

MEETINGS: Regular Meetings of the Capital Projects and Construction Committee are held on the first Monday of each month at 11:00 AM at the San Gabriel Valley Council of Government's (SGVCOG) board room, 1333 S. RECOMMENDED ACTION

Authorize the Executive Director to negotiate and execute task orders with the following firms for environmental, design, and construction support services for the Partner Cities' SMIP Phase 1 projects for the East San Gabriel Valley Sustainable Multimodal Improvements Project (SMIP):

- KOA Corporation
- Alta Planning
- H.R. Green,

BACKGROUND

In 2021, to increase the opportunities for those cities which are members of the San Gabriel Valley Council of Governments (SGVCOG) to obtain funding for specified active transportation, First/Last Mile, and bus system projects, a strategic partnership between the cities of Azusa, Claremont, Covina, Glendora, La Verne, Pomona, San Dimas ("Partner Cities"), and the SGVCOG was developed to competitively seek the FY 2022-2025 (Cycle 2) of LACMTA's Measure M Subregional Program (MSP) funds that prioritized multi-jurisdictional corridor projects and maximized regional transportation benefits.

The East San Gabriel Valley Sustainable Multimodal Improvements Project (SMIP) was derived to implement projects identified in the Arrow Highway Multimodal Corridor Plan and Metro's A Line Foothill Extension - First/Last Mile Plan, for the East San Gabriel Valley to provide critically needed First/Last Mile active transportation facilities to safely connect residents and equity focused communities to the Metro A Line (former Metro L Gold Line) in the seven Partner Cities.

The proposed improvements provide connectivity to transit stations, employment centers, schools, major entertainment, and recreational centers. Specific improvements include protected pedestrian and bicycle facilities, ADA-compliant access ramps, sidewalk improvements and repairs, bike infrastructure, bus shelter renovations, pedestrian crossing enhancements, improved lighting and landscaping, and a pedestrian bridge.

On October 18, 2021, the SGVCOG applied for and was later allocated \$14,997,974 in MSP funds from LACMTA's FY2022-2025 MSP funding cycle to implement active transportation, First/Last Mile projects, and bus system improvements in the East San Gabriel Valley for the Partner Cities. On January 20, 2022, SGVCOG staff recommended that the Governing Board: 1) program the \$14,997,974.00 from FY 2022-2025 MSP Active Transportation, Bus System Improvements, and First/Last Mile Funds for the SMIP and, 2) direct staff to work with cities and agencies that submitted applications for Category 2 Projects for design activities, to refine project scopes that



can lead to improvements that would provide regional benefits to the San Gabriel Valley's active transportation, bus system, and First/Last Mile networks.

As a result of the partnership between the SGVCOG and its seven Partner Cities, the SGVCOG will serve as the Lead Agency on behalf of the cities to: 1) manage and administer the MSP funds allocated to the SGVCOG in the amount of \$14,997,974.00 for the Partner Cities individual project components of the SMIP, 2) manage consultant solicitation(s); and 3) manage the performance of consultant activities in coordination with the Partner Cities to deliver the SMIP.

On August 3, 2023, SGVCOG solicited a Request for Qualifications (RFQ) to develop an on-call bench of qualified consultants for planning, community outreach, environmental planning, landscape architecture, and engineering design services for the SMIP Phase 1 efforts for design and construction work. The SGVCOG received a total of 12 Statement of Qualifications (SOQs)/proposals and formed a technical evaluation committee comprised of representatives from each member agency to evaluate the proposals. Based on the evaluations, all proposers were qualified for the on-call bench, which includes: 1) Alta Planning & Design, 2) CR Associates, 3) Fehr & Peers, 4) Harris & Associates, 5) HR Green, 6) Hout Construction Services, 7) JMDiaz, Inc., 8) Kimley-Horn, 9) KOA Corporation, 10) Linscott, Law & Greenspan, Engineers, 11) Toole Design, and 12) Willdan Engineering.

In order for staff to proceed with initiating task orders with consultants for the SMIP, on October 5, 2023, staff recommended that the Governing Board approve the proposed bench of on-call consultants for the SMIP and that the Governing Board assign the SMIP to the SGVCOG's Capital Projects and Construction Committee (CPCC) where the respective consultant contracts to perform the necessary task orders for SMIP Phase 1 efforts would be executed.

Once the on-call bench was approved by the Governing Board, SGVCOG staff solicited proposals from each partner city's most qualified consultant to provide services specific to each city's SMIP Phase 1 project. The most qualified consultants as rated by each of the cities were as follows:

Azusa: KOAClaremont: KOACovina: KOA

Glendora: Alta PlanningPomona: H.R. GreenSan Dimas: H.R. Green

In order to achieve economies of scale, for cities that have the same top-qualified consultant (e.g. KOA or H.R. Green), the work will be bundled under a single contract managed by the SGVCOG.

The consultants will provide the following types of services:

- Performing preliminary engineering to develop conceptual project designs
- Conducting environmental review to assess eligibility for exemptions from the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA)
- Developing designs, specifications, and estimates at the 30%, 60%, 90%, and 100% stages.
- Providing construction support, such as developing construction documents and attending meetings



• Conducting public outreach events to inform residents of the projects and promote awareness of the project benefits.

SGVCOG staff is negotiating task orders with the selected firms and anticipates finalizing contract negotiations by late February 2024. If staff is unable to come to an agreement with a city's topranked firm, staff will enter into negotiations with the respective city's next top-ranked firm. The total anticipated costs for environmental, design, and construction support services for the Partner Cities' SMIP Phase 1 projects is \$4,676,199.

FISCAL IMPACT

All funding for these contracts will come from MSP Cycle 2 Active Transportation, Bus System Improvements, and First/Last Mile Funds. There will be no net fiscal impact to the SGVCOG to complete the SMIP Phase 1 work.

RECOMMENDED ACTION

Authorize the Executive Director to execute Task Order No. 1 Revision 5 to Agreement 21-12 in an amount not-to-exceed (NTE) \$4,585,208 to AECOM to continue providing construction management services for the Fullerton Road Grade Separation Project ("Fullerton Project").

BACKGROUND

The San Gabriel Valley Council of Government ("SGVCOG") entered into Agreement No. 21-12, with AECOM on August 23, 2021 to provide professional services for the management of construction activities for the Fullerton Project for a NTE amount of \$8,905,053. The scope of these services include construction management, inspection, material testing environmental compliance, and survey work in support of the Fullerton Project. Over the course of 4 previous task order revisions the contract NTE amount has been adjusted to \$8,959,811.

CURRENT ISSUES

As of January 4, 2024, the Agency had expended \$7,207,009 for construction management services. The remaining contract capacity is not sufficient to complete the project. The additional costs are due to several factors 1) A 6-month extended project construction schedule 2) An increased level of effort for soil testing Quality Control and Quality Assurance work in response to enhanced UPRR soil compaction testing requirements; 3) Increased inspection services to monitor and support project acceleration and contractor work during extended evening and weekend hours; and 4) the original scope of work did not include material testing and inspection services for the bridge steel fabrication, bolting, and field welding.

Staff is recommending approval and execution of Task Order No. 1 Revision 5 to Agreement 21-12 with AECOM for \$4,585,208 to provide construction management services for the Fullerton Road Project for a revised not-to-exceed amount of \$13,545,019 and to extend the term of the Agreement to October 31, 2025.



In addition to the authorization of the NTE amount of \$13,545,019, an additional 10% contingency allowance, or \$1,354,501 will be budgeted for the Executive Director, to address unforeseen work or owner-initiated changes, in accordance with normal agency procedures. Any contract amount changes exceeding the Executive Director's authority will be brought back to the Committee for further consideration and approval.

FISCAL IMPACT

This Amendment will require an increase to the overall project budget. The increase will be covered by the funding for the project budget provided by Measure R, Caltrans, Trade Corridor Improvement Fund, and UPRR Contribution.

BACKGROUND

Each month committee members receive an update on key programs. Committee members may contact staff for clarifications on any of the reported items prior to the scheduled meeting. The following are items of note since the last meeting:

I. PROJECTS

Diamond Bar Golf Course Renovation Project

Construction at the Diamond Bar Golf course has been completed as of December 2023. Staff has been coordination with Los Angeles County Parks and Recreation staff on handing over maintenance and responsibility of the Golf Course to Los Angeles County in January 2024. Los Angeles County Parks and Recreation plans on opening the Golf Course to the Public in March of 2024.

Montebello Corridor Project

The contractor is continuing with pre-construction work activities. The field trailers for SGVCOG, construction management, and contractor staff have been brought on-site and are actively being used. Utility relocations for gas and fiber/telecommunications are ongoing this month, and the design for the Southern California Edison undergrounding work has been approved by UPRR. The designs for the at-grade crossing safety improvements are with UPRR's Signal Design team, with completion expected in four months, after which the Construction and Maintenance Agreement for the at-grade crossings will be finalized. In anticipation of the Signal Design approval, the contractor will begin constructing the civil works on the at-grade crossings this month. Demolition of the final remaining buildings is pending the relocation of an existing business to their replacement property.

Fullerton Road Grade Separation Project

Construction on the Fullerton Road Grade Separation Project continues. Major activities include construction and water proofing of Phase 1 UPRR bridge over Fullerton Road and the installation, backfill, and compaction of T-walls east of Fullerton Road. Contractor is also working on offsite improvements at San Jose and Rowland intersection and has completed private property



restoration work. Contractor turned over project site to UPRR to begin construction of new mainline tracks on January 23, 2024. UPRR forces have begun delivery of materials for construction of new mainline tracks. Completion of new mainline tracks is scheduled for May 2024.

La Verne Gold Line Pedestrian Bridge Project

The design consultant, KPFF completed the 100% design plans and submitted the draft GO-88B application to the California Utilities Public Commission (CPUC). The City of La Verne is coordinating with the Fairplex Goldline Project. NEPA documentation has been completed and submitted to Caltrans for their review in support of the recently granted federal earmark.

Turnbull Canyon Grade Separation Project

The contract documents for the grade separation were advertised for bid in September. Bids were due and opened on October 12, 2023. Four bids were received, and the lowest apparent bid was submitted by OHLA USA Inc. at \$69,806,991.78. The Notice of Intent to Award was published on Planet Bid and the Protest Period lasted five working days. Award of the construction contract was approved by the Committee in November. The Limited Notice to Proceed will be issued early January 2024.

State Route 57/60 Interchange Improvements Project

Construction for the SR 57/60 Interchange Improvements continues. Contractor is currently working on widening the existing Golden Springs Drive Undercrossing Bridge as well as construction of 5 retaining walls. Utility Relocations along Golden Springs Drive are scheduled to begin in January 2024.

II. COMMUNITY OUTREACH UPDATE

The following project outreach activities were conducted:

- Weekly Business Notifications: Approximately 75-100 businesses informed weekly regarding ramp and traffic lane closures related to the SR 57/60 Confluence Project
- Daily Detour Communications:
 - Sent daily detour emails to stakeholders affected by the SR 57/60 Confluence Project (e.g., Ayres Suites, Holiday Inn)
